I. Update on the Community Assistance Grant Fund Process Vice Chair Platt reviewed the process and the objectives of the Community Assistance Grant Fund Process for this introductory year with the involvement of the Commission. The Commission is currently charged with evaluating the fiscal health of the applicants. Liaison, Human Services and the two councilmembers will meet at a scheduled time to review the Commission's recommendations and feedback for next year's process. Commissioner Schreiber and Vice Chair Platt then summarized the financial conditions of the applicants and their history with the Commission. It was noteworthy that three organizations did not submit Form 990s. Three other charities submitted the public disclosures of the Form 990 which omitted helpful information. Commissioner Schreiber then reviewed some of the organizations overlapping services for food, for mental health and for the homeless population. Staff addressed the duplication in services could be intentional and be deferred to the Human Relations Commission. Staff then referred to a select few columns in the provided spreadsheet to help determine and to inform of the Commission's recommendations. While the Commission will consider the applicants' fiscal health from their applications, other information is available to the City such as external entities that have been summarized in the provided spreadsheet. Commission recommends that, if the services from the Beverly Hills Active Club are valuable to the City, the Community Assistance Grant Fund Process may not be the best avenue for this organization as they are not a legal entity. Potential recommendations include the Beverly Hills Bar Association files through the Beverly Hills Bar

Foundation who has been listed as an organization with proceeds less than 50% of total receipts. The Commission recommends extending invitation to the Beverly Hills Bar Association to attend the April meeting for the purpose of providing clarification. With concerns to the timeline, staff will follow up on few select applicants for clarification. In preparation for the April meeting, written
