#### REPORTS FROM PRIORITY AGENCIES

Operations Reports from City Departments, Consultants and Outside Agencies

- Metropolitan Water District (MWD) Director
  - o Dr. Wunderlich reported that Dr. Barry Pressman was chosen as the new MWD Director, for an initial five year term; after that, current

PWC Chair Jeff Wolfe will be taking over the directorship for the next five years.

- Since the July Public Works Commission meeting, there have been no new MWD meetings. The August Meeting is traditionally scheduled in conjunction with the release of property valuation information by the County Assessor's Office. The property value information is used to set each of the members voting percentage for the coming year and is also used by Metropolitan to assess its property tax rate for the component of Metropolitan's revenue that comes from property tax.
- o Dr. Wunderlich discussed the relevance of the Metropolitan vote with regard to the approval of the water tunnel projects.

# 2. Capital Improvement & Major Projects

Acting City Engineer Tony Antich introduced the item. The following Capital Improvement Projects are detailed in the Commission packet; the Maple Wells, Cabrillo Reservoir Project, La Brea Subarea – Central Basin Development, RO Water Treatment Plant Rehabilitation, Pump Station No. 8 Rehabilitation, North Santa Monica Boulevard Reconstruction, Purple Line Subway Extension – Metro, Citywide Street Resurfacing, Sidewalk Maintenance Inventory and Traffic Signal Modification and Curb Ramp Replacement – W. Olympic Blvd. /Beverwil Drive/Beverly Drive.

A detailed report was provided on the Santa Monica Blvd project. This coming week, the traffic pattern will be altered, with work taking place between Canon and Alpine. There has been coordination with the B.O.L.D. program to ensure a successful community event.

## Commissioner comments:

- It was suggested, to help traffic flow in the area, to have a left turn arrow at the west bound intersection of Santa Monica Blvd. and Beverly Blvd.
- The Commission inquired when the feasibility study from the Cabrillo Reservoir will be available.
- The Commission expressed interest in engaging with staff in the initial review process on select projects as well as the development of the Capital Budget from the beginning of the year.
- The Commission is also interested in having a diversion element in the system so the aquifer can be recharged.
- The Commission suggested a possible future Agenda item with regard to Pump Station 8.
- There was a request to review the paving schedule for accuracy.

Staff will continue to refine the format of this report.

## 3. Fleet Services Overview and Accomplishments

Fleet Manager Craig Crowder presented a PowerPoint about the Fleet Program for the City of Beverly Hills.

He provided a description of the fleet operation, the vehicle inventory, regulatory concerns from various agencies, an example of a replacement analysis for a vehicle, the vehicle procurement process as well as some recent grant opportunities and fleet center highlights and recent recognitions.

Staff is currently working on receiving tax credits for natural gas we have produced from the (Compressed Natural Gas) CNG Station. A CNG Fuel Credits and renewable natural gas item will be agendized at a future meeting for further discussion.

- Concerned with getting tax credits for CNG Fuel.
- Commented about mileage and repair of CNG trucks.
- Concerned with timing of grant reimbursements.
- Kudos were given to the Fleet Division for their past and recent accomplishments.

# 4. Hollywood Basin Wells Scale Pre-Treatment Testing Update

Water Resources Manager Vince Damasse provided a brief overview and advised the Commission of the ultimate goals. Staff may have pictures and a detailed update by Carollo by next month's meeting. We are currently on budget for the project.

## Commissioner comments:

- Asked about type of rehabilitation being done on Well #5.
- Concerned with future access to the site.
- Commission would like to be made aware of differences with estimates/costs.
- Commission would like to have other forms of testing done simultaneously.
- Commission commented about green sand filters and their possible location in the current PO Plant.
- Commission commented on the communication of updates so it is easier to understand when there are modifications.

## **NEW BUSINESS**

#### 5. Public Works Bidding

Acting City Engineer Tony Antich reported on the bidding practices for the City of Beverly Hills and the bidding practices of other agencies. He advised that rules of public bidding are different in different cities. The purpose of a public bidding process is to discourage favoritism and fraud, not to get the lowest price. He reviewed the procedure and criteria for bidding, the prevailing wage requirements, and factors or perceptions of why Public Projects can cost more than Private Projects.

#### Commissioner comments:

- Commission commented that the water projects seem to be over budget and might need further analysis.
- Commission commented about incentives and liquidated damages and the use of them in our process.

## 6. Metro Purple Line Extension

Project Manager Robert Welch provided a project overview and statues update for Sections #1 and #2 of the Purple Line Project.

- Section #1 includes the Wilshire/La Cienega Station and Section #2 is the Wilshire/Rodeo Station.
- Traffic detours and weekend closures with regard to decking installation were discussed.
- There has been city-wide coordination for the street closures.
- Utility relocation work was also outlined.
- Community Outreach efforts were reviewed.

## Commissioner comments:

- Commission commented about having more than one portal opening for the metro stations.
- Commission is concerned with time that the construction can take place. There is an independent compliance monitor on site. If there are questions, the Metro hotline number can be called for further information.
- Noise monitors are also present to assure compliance.
- Commission suggested live stream cameras for residents to track progress of project and/or traffic.

  - o Commission requested an update on the street light project. Staff reported there might be financing assistance from SCE available.
  - o Commission also asked for a comment on the environmental working groups for water quality.
  - Commission reminded staff to set meeting for review of comments about the (Preliminary Design Report) PDR.
  - Development in West Hollywood and the current will serve process is in conflict with Beverly Hills' desire to increase to self-reliance of its local water supply.
  - o Commission recommends budgeting for a grant writer.
  - o Proposed a future Agenda item about the cleanup of the Sand Pit and Coffee Bean sites.
  - Suggestion to look at a 9900 Wilshire Blvd. project payment and advise what percentage is allocatable to us.
  - o Commission asked to coordinate with Southern California Edison to attend Quarterly Meeting and relay input from customers on power outages.
