5. 2017 Election Civility Statement Implementation

Byron Pope, City Clerk, presented an overview of the 2017 City Council Municipal election in addition to the City Treasurer's election. In the candidate's information packets, the cover letter from the Commission that was signed by Chair Popovich Levyn, was included in addition to the Human Relations Civility Statement.
