# City Planner Updates

City Planner Ryan Gohlich provided updates on the following:

- At the November 7, 2017 Study Session meeting, there was not sufficient City Council support to call up the Planning Commission's decision on the project at 9200 Wilshire Boulevard
- At the November 7, 2017 City Council formal meeting, the City Council denied appeals for both the staff interpretation regarding the definition of basement in the Beverly Hills Municipal Code, and the Planning Commission's decision to deny a request for a Hillside R-1 Permit for the property at 1260 Lago Vista Drive
- Also at the November 7, 2017 City Council formal meeting, the City Council
  accepted the Vehicle Access Easements and proposed vacation of the Storm
  Drain Easement related to the properties at 1184 and 1193 Loma Linda Drive
- The Basement Ordinance, which was recently recommended by the Planning Commission, is tentatively scheduled to appear on the December 5, 2017 City Council formal meeting agenda
- The Planning Commission will hold a special evening meeting on Tuesday, November 28, 2017 to consider the proposed project at the former Friars Club site
