4. Proposed Acquisition of Lichtenstein

Chair Kaye reported that the consideration of purchase of the Lichtenstein sculpture Coups de Pinceau had been brought forward to the FAC/Council Liaison. He also reported that he had met with representatives of the Lichtenstein Foundation, and that they had expressed their desire for that sculpture to remain in the City of Beverly Hills. The Foundation would be willing to consider an offer of purchase by the City. The Commission discussed if there was interest to pursue this potential acquisition.

B. Waldorf Astoria Project

Staff updated the Commission in regards to the architectural element that is proposed to be placed at the corner of Santa Monica Blvd. and Wilshire Blvd.

C. Tom Friedman Commission

Staff and City Attorney's Office are reviewing the proposed changes to the agreement that were sent by the Gallery. This agreement is estimated to go to City Council for approval at one of the City Council meetings in February.

D. William Kentridge World on Hind Legs

Staff received updated structural engineer drawings of the revised base. Staff will bring estimates for the revised concrete base and lighting vendor to the February meeting.

E. Bove Update

Staff is proceeding with creating an agreement with the vendor recommended by the Zwirner Gallery to provide a cleaning and maintenance treatment for this piece.

F. Website Link to FAC Speaker Presentations

Staff has updated the Fine Art Commission's webpage to include links that will take viewers directly to the special guest presentations. The Commission requested that Staff adds photo of the speakers next to each link.

G. Gagosian Gallery – Richard Serra Sculptures

A Fine Art City Council liaison meeting was held on 12/19/16. The City Council liaisons did not feel that they could support the purchase of the Richard Serra *Twins* piece at the price point that has been proposed by the Gallery.

H. Fine Art Obligation - Covenants

Staff gave an update on the covenants that have been recorded to date. The Commission was not satisfied with the progress and would like to seek support from the City Attorney's Office.

I. Update on Border around Spiral of Life

The border around the artwork has been repaired.

J. Update on lighting around Kusama

The timer for the lighting of this art piece has been adjusted.

K. Lighting donation for Sisyphus

Murray Pepper has approached Staff about donating new lighting to be installed around this sculpture. Staff is working on recommendations for new LED lighting fixtures and cost estimates.
