2. Proposed Acquisition of Lichtenstein

With the permission of the Commission, Chair Kaye made an offer to the Lichtenstein Foundation to negotiate the potential acquisition of the Lichtenstein. That offer was not accepted. The Commission thanked Diane Rosenstein for her efforts.

The Commission had consensus not to pursue further the purchase of the Lichtenstein nor the Serra.

3. Kusama Update

Staff reported that an email and a formal certified letter had been sent to Ota Studios, asking them for help in resolving the issues with the Kusama sculpture. The studio has received the letter but they have not yet responded. Staff will continue reaching out to the Studio.

Staff also reported feedback from City Attorney's Office and Risk Management's Office, in regards to the issues with this sculpture.

The Commission inquired about the possibility to cover and protect all sculptures in Beverly Gardens Park from being exposed to dust and debris from the construction project on Santa Monica Blvd.
