2. Kusama Update

Staff reported that they have been in contact with OTA Studio reviewing the issues with this art piece. The studio feels that the problems were caused by public interaction even though problems have reappeared even after protecting the piece with the fence. The studio is looking at cost and process to refabricate the piece in Japan, and have it sent to Beverly Hills. The studio does not feel that the piece needs to be refabricated in concrete-fiberglass composite. Complete information will be provided for a decision to be made on next steps.

3. Bove Update

Staff reported that they received formal legal correspondence from Zwirner Gallery. Staff will include this item to the next Liaison meeting on August 28th for discussion and to City Council closed session for recommendation on September 5th.

6. Proposal of Fine Art Obligation 9701 Wilshire Blvd.

Brad Adams representative for the property on 9701 Wilshire Blvd. presented to the Commission the art by artist Randy Bloom that is currently installed in that property, and inquired if this art would qualify towards the property's Fine Art Obligation. The Commission discussed if this proposal met the criteria in terms of fine artist qualification and installation location. The Commission requested that they provide art appraisal or comparable sales value of the piece, as well as relocation of the piece to a public visible area. The Commission also presented to the representative the possibility of paying the Fine Art Obligation in-lieu fee.
