NEW BUSINESS

Introduction of Public Works Director Shana Epstein – taken out of order

Director Shana Epstein introduced herself to the Commission, and explained some of the new services that Public Works offers.

• FY 17/18 Community Assistance Grant Funding Update – taken out of order

Jim Latta, Human Services Administrator, updated the Commission on the status of the Community Assistance Grant Funding applications. He informed the Commission that three organizations were contacted to provide additional information: Beverly Hills Bar Association, Public Council, and Bet Tzedek. Ultimately, Beverly Hills Bar and Public Council decided to drop their requests for funding; therefore, leaving only Bet Tzedek for consideration. Since Bet Tzedek has already been vetted and approved by the Charitable Solicitations Commission, no further action is required from the Commissioners.

Commissioner Fischer expressed his concern that the CAGF is limiting its scope in legal services by only referencing tenants and not landlords and strongly recommended that the legal service provide assistance to both.

the legal services to be provided are not only for tenants but also include landlords, and that if a criteria is to be determined for the landlords it be

primarily for owner occupied or 2-4 unit buildings (5-0).

Ultimately, it was decided not make any changes with respects to permit issuance practices.

COMMUNICATIONS FROM STAFF

- Staff Report
 - a) Los Angeles County Police Canine Association Update taken out of order

Staff informed the Commission that a letter was sent to the LACPCA outlining the concerns expressed in the May CSC meeting by the Commission, and asking them to respond regarding whether or not a portion of money directly received from Beverly Hills solicitations could be used towards funding programs, equipment, support, etc. for BHPD's K-9 Unit. Staff has not yet receive any response.

b) Briefing Regarding Changes to the Municipal Code

Capt. Rosen gave an overview of the events that led up to the review of the Commission's proposed changes to the Municipal Code as presented. Capt. Rosen also stated that he is in the process of collecting the municipal codes from other similar local governments in order to use them as resources and content to the Beverly Hills Municipal Code as it related to charitable solicitation. He plans to have some best practices to present to the Commissioners at the July meeting.

Additionally, Capt. Rosen recommended that the Commission determine the goals, scope, and aims of the Commission, short-term and long-term, and use these goals to guide them in determining their proposed changes.

Several Commissioners voiced their dismay and disappointment with having to review and go through the process of revision again. It was their understanding that the proposed changes had been vetted by and approved by the City Attorney's Office, and the Council Liaisons. The City Attorney, the City Manager, and Police Chief were invited to attend the next meeting to further discuss the matter in detail.
