• FY 17/18 Community Assistance Grant Funding Update - taken out of order

Jim Latta, Human Services Administrator, updated the Commission on the status of the Community Assistance Grant Funding applications, which were presented to City Council on May 16, 2017. The Commission asked about the criteria to be used to determine the beneficiaries of legal services to be funded by a Community Assistance Grant. Two Commissioners felt that both landlords and tenants should be eligible for funding based on the merits of the dispute.

COMMUNICATIONS FROM THE COMMISSION

- Chair's Report
 - a) April 27, 2017 Mayor's Cabinet Meeting

Chair Schreiber made the Commission aware of the new format for the Mayor's Cabinet meetings. Mayor Bosse conducts a more structured meeting, which is now video recorded. Minutes or Highlights are no longer created as a result.

The Design Review Commission is currently still looking for a third applicant before filling their open commission seat. The Public Works Commission mentioned that the Burton Way medians will be watered with non-potable well water. The Health and Safety Commission presented their tentative plan to further restrict smoking areas within the City.

b) May 5, 2017 Council Liaison Meeting

The Chair informed the Commission that the purpose of this meeting was to make the City Council aware of the significant number charitable fundraising events held the Beverly Hills that were not permitted by the City of Beverly Hills and to request additional resources to alleviate this issue.

The timing of the presentation of the Commission's proposed amendments to the BHMC was also discussed, and it was determined that a preamble needs to be included in the BHMC before it is accepted by the Liaisons. The preamble would clarify the scope and goals of the Commission.

Comments from Commissioners

The Commissioners expressed their frustration with the new format of the Mayor's Cabinet Meetings. Minutes or Highlights would still be useful to the Commissioners in order to provide an overview of the meeting, rather than having to watch the full video recording.

Additionally, regarding the Council Liaison Meeting, the Commissioners requested that the City Manager come to the next CSC Meeting to further explain his requests regarding the BHMC to the entire Commission.

The next CSC Meeting will be held on Wednesday, June 7, 2017.

 - a) Los Angeles County Police Canine Association Update taken out of order

Lieutenant Michael Hill of the Beverly Hills Police Department addressed the Commission regarding the Los Angeles County Police Canine Association (LACPCA). While LACPCA was invited, and stated a representative would attend to answer questions from the Commission, no such representative was present.

Commissioner Fischer asked Lt. Hill to state how BHPD's K-9 Unit benefited from LACPCA. Lt. Hill stated that BHPD is a member of the association, and as such benefits from training opportunities and has access to specialized legal aid.

Commissioner Fischer further requested that LACPCA be contacted and asked if a portion of Beverly Hills solicitations be allocated for specific use by the BHPD K-9 Unit.

Lt. Hill and Staff will follow-up with the LACPCA.
