#### 2. Tenant Landlord Forum

Human Services Administrator James R. Latta updated the Commission on the submitted forms and calls received to the Human Services Division from both Tenants and Landlords. There were not any speakers at the Forum.

# 3. Rent Stabilization Update

Director of Community Development Susan Healy Keene provided an update to the Commission on the Amended Rent Stabilization Ordinance that was provide to City Council on April 20, 2017 in addition to the update that was presented on June 13, 2017 and provided a timeline of the project.

The Tenant/Landlord handbooks are updated and are available online and hard copies are available in City Hall.

The new and updated Rent Registry form was reviewed and discussed. Sessions will be scheduled for the public in addition to one on one appointments to assist with the submission of the form.

Public Education Workshops have been schedule for Saturday, June 17, 2017 in the Beverly Hills Public Library Auditorium from 10am to noon, in addition to Thursday, June 22, 2017 in City Hall from 7pm to 9pm to answer any questions or concerns.
