### 3. Third Street Parking Meters and Bike Rack

Deputy Director of Transportation Aaron Kunz provided a brief presentation on the re-examination of the 10-hour parking meters on the north side of Third Street, adjacent to the 331 Maple Drive building and the bike share station at Third Street/Maple Drive, per the request of resident David Gingold.

Motion: MOVED by Commissioner Seidel, SECONDED by Vice Chair Solnit that the bike rack at Third Street and Maple Drive remain as-is in terms of location and number of bikes, pending any compelling information that indicates representation of any hazard or economic unfeasibility. The Commission supports the status quo regarding the duration of the meters along Third Street, as this is under the purview of the Staff (5-0).

### 4. South Santa Monica Boulevard Parking Strategies

Deputy Director of Transportation Aaron Kunz and Iteris consultants Michael Meyer and Deepak Kaushik provided a report on options for South Santa Monica Boulevard parking strategies after construction, including returning parking meters to the previous configuration, and a "hybrid" alternative with parking on the north side only. Consultant Michael Meyer also mentioned that some community members were not in favor of returning parking to the street.

The Commission requested that staff bring the item back on February 1, to make a recommendation to restore parking, and return to the previous configuration or the "hybrid". The Commission does not recommend continuing with "no parking".
