Transportation Planner Martha Eros provided a report on proposed approaches to regulate shared mobility systems and devices, including amending the Beverly Hills Municipal Code to define shared mobility systems and devices and discuss potential options to regulate usage and activity of shared mobility devices within the City.

The Commission unanimously provided direction to pursue amendments to the municipal code to define shared mobility systems and devices and authorize staff to impound motorized scooters abandoned on the public right-of-way. Chair Meshkaty and Commissioners Manaster and Seidel favored further study of vendor regulation, while Vice Chair Solnit and Commissioner Hendry preferred a prohibition of motorized scooters.
