## REPORTS FROM PRIORITY AGENCIES

- Beverly Hills School District Isabel Hacker, Board Member, and Chris Hertz, Director of School Safety, presented a number of health and safety related issues including DART Day, which took place on April 2, 2018, the formation of the Safety Advisory Committee comprised of parent volunteers, the installation of a CCTV camera by the Beverly Hills Police Department and the Beverly Hills High School shelter in place and evacuation drills.
   Ms. Hacker concluded with an update on the Board's plans to provide educational outreach on anti-smoking and the hazards of vaping to parents and students.

### **CONTINUED BUSINESS**

## 1. Health and Safety Recognition Program – Ali Norman-Franks

Chair Myra Demeter and Commissioner Myra Lurie nominated Ali Norman-Franks for the recognition program. In 2008, Ms. Norman-Franks established the Norman Aid Center on the campus of Beverly Hills High School where she and a team of Maple Counselors, interns, Pupil Personnel Service interns and peer counselors help with a range of student needs through crisis management and mental health education throughout the school.

# 2. Disaster Preparedness

Meena Janmohamed, Management Analyst, provided a brief presentation on disaster preparedness related mobile device apps. Organizations such as FEMA and the American Red Cross have developed helpful apps which provide useful information before, during and after a disaster. "Pocket First Aid and CPR," an app developed by the American Heart Association, helps people stay prepared while on-the-go. "Gas Buddy" helps drivers find the gas station locations closest to them. Finally, two apps which track earthquakes using data from the U.S. Geological Survey (USGS) include "Quake Alert" and "Quake Feed." Commissioner Lurie added that more information for earthquake preparedness can be found on the California Department of Conservation's website <a href="http://www.conservation.ca.gov">http://www.conservation.ca.gov</a>.

## 3. April is Earthquake Preparedness Month

Meena Janmohamed, Management Analyst, focused on the importance of earthquake preparedness throughout the community with the "When It Rocks...Are You Ready to Roll" campaign and shared tips on earthquake preparedness. Some tips for residents include creating an emergency plan and stockpiling supplies. Businesses are reminded to become Disaster Ready partners. Earthquake preparedness educational information and outreach is being done throughout April on radio ads, cable TV programming, the City's website and by placing banners at various City locations.

## 5. Complete Streets Plan

Martha Eros, Transportation Planner, provided the Commission with an introduction to the Complete Streets Plan, which serves as the guiding document in the development and implementation of future mobility modes for walking, biking, public transit and vehicles throughout the City. The Complete Street Plan is being presented at upcoming workshops and outreach events on May 30<sup>th</sup> and August 22<sup>nd</sup>.
