Dr. Pressman gave an overview of the Statewide Water Resilience Portfolio Development. He discussed the snowpack functions, sea level rise, potential water resources impacts, and seismic risks.

City Engineer Daren Grilley updated the Commission on the Capital Improvement & Major Project items. Specifically updated were the Pump Station #8 Rehabilitation, Water Main Replacement Projects, Sewer and Storm Drain Project and the Oil Well Plugging Project.

4. Foothill Water Treatment Plant Update/La Brea Subarea Update
Project Manager Samer Elayyan reported on the design progress for the Water Treatment
Plant. Carollo staff present were Senior Vice President Eric Mills, Design Lead Vincent
Roquebert and Staff Engineer Pei-Shin Wu. They reported on the water quality results and the
pre-treatment process as well as the layout and the media filter. As reported, the minor design
changes will not be a significant change in building or operating costs.

Water Resources Manager Vince Damasse commented on details of some of the equipment for the water treatment plant.

Mr. Damasse and Project Manager Tristan Malabanan updated specifics of the La Brea Subarea Project.
