Staff presented information and a brief history of the City's means for addressing the issues of bulk and mass of residential projects, which included the establishment of the Design Review Commission in 2004, the associated Track 1 (staff-level) approval process, and the 2013-2014 Citywide Study to reduce the bulk and mass of single-family residential projects.

Specific points of discussion included the Commission's existing authority when reviewing and potentially approving projects, and the public perception of Commissioners' presence and testimony at other public hearings.

Chair Sherman inquired if a public forum to assist applicants in navigating the Design Review process could be scheduled. Staff will explore that and other opportunities for public outreach.
