2. Cultural Arts Expansion

Staff also reported that estimates are being procured for this installation. This item will be presented to City Council for full approval on February 19th or March 5th, 2019. Staff will update the Commission on final date and invite the Commission to attend this meeting.

Finally Staff discussed the need for clarification if the Tom Friedman sculpture will need lighting, this item will be included in the February agenda.
