CONTINUED BUSINESS

2. Bove Raising Update

Staff reported to the Commission that the Liaisons chose the rendering reflecting the bow tie shape with wide center to surround the sculpture. The Liaisons also gave direction to staff to add flowers to the landscaping rendering to further protect the sculpture from people stepping and climbing on it. The Commission preferred the triangle shape and no flowers but they decided to compromise and follow the Liaison's direction. The Commission also discussed the possibility to replace the DG and the mulch surrounding all the art pieces, and to replace it with simple green ground covering, similar to the Bove to give continuity throughout the park.

Staff will share the Commission's comments along with the Liaison's recommendations when this item is presented in the City Council session. The Commission requested that Staff informs City Council that the Commission did not know any cost involved for this project when they made this recommendation, and that the sculpture's artist likes something more austere surrounding the piece.

5. Director's Report

A. Fine Art Fund Report

Information was provided in packet. The Commission asked Staff to highlight in the reports the most current fund entries.

B. Tom Friedman Update

Staff has worked with the gallery to identify an installation date for this art piece, October 2018 is the tentative date. The engineering drawings are ready, and they are finalizing some details for the fabrication drawings and the platform drawings. Public Works is helping with the review of drawings and with the permits for this project.

C. Fletcher Benton Status Report

The sculpture has been installed. The dedication for this art piece will take place on July 17th at 1pm.

D. Kusama Warranty Extension and Engineering Study Update

Staff has been working with Ironwood on procuring the engineering study. The Kusama warranty extension will be presented to City Council on July 17th.

Staff included in the packet the priorities proposed by the Commission and approved by City Council as part of the budget session.

F. Carl Milles Referral for Future Review and Purchase Consideration

Councilmember Mirisch asked that the Commission looks at the work of artist Carl Milles and perhaps consider his work for the upcoming priority exercise. Commissioner Vahn and Hiller will look at potential pieces from this artist for consideration by the Commission.

G. Art Signage Update

Staff reported that the new art signage has been installed by the identified sculptures at Beverly Gardens Park. The Commission preferred the art signage to be installed away from the platform of the sculptures and they agreed to have 1 sign installed per sculpture, except the Bove which will have 2 signs installed. The Commission also requested to remove the old do not touch signs installed by Kusama. A discussion took place about ideal placement site for the Tony Smith sculpture plaque.

ROTATION OF FINE ART COMMISSION CHAIR / VICE CHAIR


