I have been living in Beverly Hills with my husband and two sons, since 2015. I am interested in regional traffic and parking issues - and enjoy keeping up with city, regional and worldwide urban planning issues. I have a lot of patience and a calm demeanor that has earned me accolades in my current workplace for exceptional client relations. I am able to make rational and thoughtful decisions, as well as stand on my convictions.

5. What do you see as the major traffic issues currently facing Beverly Hills?

Speeding is a big and constant problem in many neighborhoods, especially along Olympic Blvd and in the southeastern residential streets. When a street is designed like a dragstrip, drivers will use it as such. That's why it's impossible to enforce drivers out of speeding. Speed mitigation measures like cameras have been installed, but the problem has not subsided over the years. Streets can be designed that intrinsically encourage safe driving. Elements such as raised crosswalks, pedestrian islands, curb extensions, shorter crosswalks, and tighter intersection corners - all increase the chance that drivers will do the right thing and make it difficult to make a life-threatening mistake. The adoption of the Complete Streets Plan by the City is an exciting prospect and I look forward to its implementation. Existing road conditions create conflict and danger. When cars and bicycles must share the road - it is at great peril to both. In Beverly Hills, bicycles riders often prefer the safety of the sidewalk and then endanger pedestrians, Grade protected "mobility lanes" resolve this inherent disorder and make streets safe for all users - regardless of age. A 13-year study of a dozen cities found that protected bike-lanes led to a drastic decline in fatalities for all road users; painted bike-lanes provided no safety improvement at all; and 'sharrows' decreased safety for all road users (so it was safer not to have them installed at all). The conclusion of this study reinforces that it is a moral imperative of the City to improve streets to protect the safety of all citizens. Beverly Hills prides itself on great schools and touts that it is a healthy city. Providing kids and older adults with safe (multimodal) alternatives to get to schools, parks and community facilities is an imperative. With the imminent opening of two subway stations, the streets of Beverly Hills must be prepared to accommodate the influx of people arriving and departing from the stations - via foot, bus, bike and/or city shuttle. Anticipating and bolstering all modes of active mobility to and from the stations is vital.

6. What do you see as the major parking issues currently facing Beverly Hills?

The city had the fortitude to invest in many public parking structures in prior years. These parking structures provide convenient, inexpensive and plentiful parking throughout the city's commercial areas. Street parking in these areas is redundant and detrimental to vibrant urban life. Removing street parking would create more pleasant streets creating room for parklets and outdoor dining. These could be places for people to linger and discover businesses they hadn't intended to patronize. Beverly Hills would thrive with increased public spaces! The increase in street life in the Golden Triangle, as of late, thanks to the City's proactive popular outdoor dining program (along with the removal of street parking spaces) has been a boon! My husband and I find ourselves frequently strolling around because it is so much more pleasant (than before). Without the pandemic, these parklets would have been opposed and not come to fruition. The important lesson is that these inexpensive urban experiments are worthwhile. When people experience new things, they find they actually like them, even though they might have opposed them originally. Neighboring cities like West Hollywood have approved closing Robertson Blvd. to cars on Saturday nights and Sunday. This is a cost effective and fun experiment that could be tested out on Beverly Hills streets i.e Beverly Drive, to help attract residents and restaurant patrons.

7. Why do you wish to be a member of the Traffic and Parking Commission? (Specifically, why have you chosen this form of community service over the many other avenues of community service available in our community?)

I have been interested in cities for as long as I can remember and interned at the City of Beverly Hills Office of Community Development while at Beverly Hills High School in 1990. During the course of the pandemic, I have taken up biking - along with many others. Biking makes one acutely aware of the inequity of city streets because streets are designed for cars. I have delved into the topic through recent literature on the subject; twitter feeds that track contemporary worldwide urban transformations; and via friendships forged in City Zoom meetings. The brewing climate change emergency, the diminishment of public health and the lack of community are all rooted in the unbalanced prioritization of cars on our streets. As part of my work as an architect, I feel a great deal of pride in the work I do regarding equity specifically accommodating the needs of the disabled. This work is mandated by the State (via the California Building Code) and the Federal Government (via the Americans with Disabilities Act). I have gained an awareness and appreciation of the importance of the Government's role in providing vision and leadership for equity by adopting the ADA and protecting disabled people's civil rights. This has inspired me to become more active in my community and to engage in the work of protecting the rights of all street users as a Traffic and Parking Commissioner.

5. What do you see as the major traffic issues currently facing Beverly Hills?

I've lived in Beverly Hills for just over 26 years. The traffic on Alta Drive, on Santa Monica Blvd, and elsewhere in Beverly Hills is much worse now than it was 25 years ago. When I first moved to Beverly Hills, it took me 25 minutes to drive to my job in downtown Los Angeles. Now the same drive takes me 35 - 40 minutes. That increase is reflected all across Beverly Hills and the broader Los Angeles community. The quantity of traffic on the major roads increases the pressure on the smaller residential streets. Many people use Carmelita and Elevado, as well as Charleville and Gregory Way to avoid the traffic on larger streets. When we moved to Beverly Hills it was more or less safe for children to play in the street - no longer. To the extent that Beverly Hills residents would like to ride bicycles around town, or use buses rather than cars, it's very difficult. The bike lane on Santa Monica Blvd is right next to traffic that whizzes by. It feels unsafe. We need more public transportation and we need more transportation options both intra Beverly Hills and through Beverly Hills.
