

# BEVERLY HILLS POLICE DEPARTMENT EXECUTIVE SUMMARY December 2022

### **Crime Summary**

In December 2022, we saw a **21%** increase in overall offenses<sup>1</sup> compared to November 2022. Overall total offenses are marginally up by **9%** year-to-date. We have had two hundred and five offenses committed thus far in 2022 compared to 2021. Our response time to emergency calls for service is 2.44 minutes, and we received 3,234 community-generated calls for service.

#### **Community Engagement**

- Conducted residential, business security assessments and formed a new Neighborhood Watch for Beat 5, which includes the 9800 and 9900 blocks of Durant Drive, Robbins Drive, Young Drive, and Lasky Drive. - Created a series of videos for social media which highlighted BHPD holiday activities with Beverly Vista Middle School, Hawthorne Elementary School, Horace Mann Elementary School, and Hillel Hebrew Academy.
- Community Relations Sergeant Jesse Perez was promoted to Patrol Lieutenant. We would like to express our appreciation to Lieutenant Perez for his exceptional work and dedication over the past year.

#### **Detective Bureau**

- In December 2022, officers conducted a traffic stop on a stolen Mercedes AMG. During the investigation, officers discovered the suspect to be in possession of fraudulently obtained credit/debit cards. The suspect was arrested, and detective personnel used additional information to continue the investigation. Detective personnel determined the suspect had a lengthy history of identity theft and fraud. Numerous other credit/debit cards were found inside the stolen vehicle, and detectives were able to identify several other victims of fraud, identity theft, and elder abuse. Detectives served several search warrants seizing stolen mail, debit/credit cards, and checkbooks. The case was presented to the Los Angeles County District Attorney's Office, where several felony counts of Identity Theft with a Prior were filed.
- In November 2022, a grand theft from a motor vehicle occurred in the 100 block of S. Roxbury Dr. Suspects walked to the victim's vehicle, opened the doors, and stole property. The victim called the department to report the crime shortly after determining their property was stolen. With the assistance of the Real Time Watch Center (RTWC) and detectives, CCTV footage of the crime was found. The victim supplied video footage of the crime from his vehicle's cameras and assisted detectives with the identification of the suspects. In December, after a complete investigation, the case was submitted to the Los Angeles County District Attorney's Office, where counts of Grand Theft were filed.
- In December 2022, a burglary from a motor vehicle, vandalism, and a grand theft occurred. Detectives conducted immense follow-up, and with the assistance of the Real-Time Watch Center were able to associate all three crimes involved the same suspects. Detective personnel determined that some of the stolen property had tracking capability. Detectives were able to identify the location of the stolen items, and potential suspects. Detective personnel conducted several hours of surveillance, which resulted in a search warrant of the location. This resulted in the arrest of suspects, and the recovery of the stolen property less than 24 hours after the crimes.

#### **Traffic Division**

Crime Category	Sub-Category	Description
ASSAULT	Assault – Aggravated	An assault with a weapon or with the intent to inflict severe or aggravated bodily injury.
	Assault – Simple	An assault with no intent and not resulting in severe or aggravated bodily injury.
	Assaults – Prior to Sept 2018	All aggravated and simple assaults (previously combined).
BURGLARY	Burglary – Commercial Building	Entry into a commercial business after business hours with the intent to commit theft
	Burglary – Construction Site	Any entry onto a construction site with intent to commit theft.
	Burglary – Residential (Accessed Garage Only)	Entry <u>limited</u> to a garage (subterranean, attached to residence, detached from residence) with intent to commit theft.
	Burglary – Residential (Home Occupied)	Entry into a residence with the intent to commit a theft or any felony while the residence is occupied at the time of the crime.
	Burglary – Residential (Common Area)	Entry <u>limited</u> to a common mail area or laundry room of a multi-family residence with the intent to commit mail theft or coin theft.
	Burglary – Residential (No One Home)	Entry into a residence with the intent to commit a theft or any felony when no one is home at the time of the crime.

## **NIBRS Transition & Frequently Asked Questions**

#### Introduction:

The FBI's Uniform Crime Reporting Program is a nationwide, cooperative statistical effort of federal, state, county, city, university, college, and tribal law enforcement agencies reporting data on offenses reported or known since 1930. Originally, the UCR Program was designed as a summary system to collect only the single most serious offense within a reported incident. UCR summary reporting provides an aggregated monthly tally of specific crimes to include: homicide, rape, robbery, burglary, and larceny.

In 1989, after years of redesigning the UCR Program's ability to gather crime details, incident-based reporting (NIBRS) was created to improve the overall quality of crime data collected by capturing all offenses within a crime incident reported to law enforcement instead of only one offense.

#### How does NIBRS differ from UCR?

NIBRS differs from UCR in that it collects additional details on every crime incident such as: multiple offenses within the same crime incident, information on victims, information on known offenders, the relationships between victims and offenders, arrestees' information, and the property involved in the reported incident. NIBRS has the ability to provide circumstances and context for crimes such as location and time of day. Nationwide implementation of the FBI's NIBRS became top priority requiring all local, state, and federal law enforcement agencies to transition to the updated method of reporting crimes. As such, all law enforcement agencies in the state of California are mandated to transition to NIBRS reporting.

# How will NIBRS impact the way in which crime statistical information is reported and presented to the community?

NIBRS reporting will impact the way in which crime statistical information is reported and presented to the community as more incidents will be required to be reported.

For example, using the following hypothetical circumstances:

An offender breaks into a home and removes property from within the home (a burglary); the offender also removes property from the inside of an unlocked vehicle in the garage (a petty theft) and lastly, the offender graffiti's the front door as he exits the home (a vandalism).

Under the UCR model, only one crime that was classified as the most serious is reported; however, under the NIBRS model, all three crimes will be reported. This new reporting model will give the appearance that more crimes have been committed, even though the total number of crime incidents may be the same. During the first few months of the transition, Staff will continue to provide UCR crime statistical information alongside NIBRS crime statistical informational to allow reviewers to see a side-by-side comparison. The first monthly crime statistics report has been published in early September for crimes occurring in the month of August.
