### 4) Reducing Crime and Keeping California Safe Act of 2018

- Chief Coopwood advised legislation is supported by California Peace Officers Association, California Police Chiefs Association and California State Sheriffs' Association.
- Chief Spagnoli provided information on property crimes and accountability for recidivism. She further advised the state would like to see rehabilitation of the criminals outside of the jail system but the state is providing no funding for those programs.
- Both Liaisons support this initiative.
