Gary Ross and Daniel Nazarian have served as the Chair and Vice Chair from January 2019 to December 2019.

The areas of interest for 2019 included:

- Smoking Education, Outreach and Cessation
- Youth Health and Safety

During this time, the Health and Safety Commission accomplished the following:

1. Continued the Health and Safety Recognition Program, honoring individuals, businesses, and groups who have demonstrated leadership in the field of health and safety issues or made a contribution to the mission of the Health and Safety Commission.

3. Continued learning about the topic of Youth Health and Safety and received customized presentations each month.

	Kim Low and Nadia Akhtar Sim, Clinical Supervisors and Co-Program
	Coordinators for the Adolescent and Child Therapy Program (ACT) at The
	Maple Counseling Center, provided a presentation to the Commission
	regarding different programs and services offered including individual
	counseling, family counseling, parenting groups, assessments, and

	treatment plans. At the NormanAid Student Support Center at the Beverly Hills High School, there is crisis counseling, group sessions, and ongoing therapy services and next month will assist with the Every 15 Minutes Program. The SOS Program helps identifies students with signs of depression or suicide. Payment at The Maple Counseling Center is on a sliding scale and free at the schools.
February	Terrance Dunn, BHUSD Student Services Coordinator, and Mark Hernandez, M.Ed.L, Los Angeles County Office of Education TUPE Program Coordinator, addressed the Commission regarding the TUPE (Tobacco Use Prevention Education) program, educating parents on youth smoking cessation, the Project Towards No Drug program, and the NormanAid Student Support Center. They discussed the possibility of expanding to middle school education.
April	Meena Janmohamed, Emergency Management Analyst, spoke to the Commission regarding emergency and disaster information and tactics for youth. Additionally, April is Earthquake Preparedness Month.
Мау	Jennifer Lev, Recreation Services Manager, informed the Commission about safety procedures for youth in the Beverly Hills Basketball League, the Beverly Hills Little League, and the American Youth Soccer Organization. This includes health and safety officers, training, coaching standards, child protection policies, medical release forms, and general liability insurance.
June	Dr. David Heber and Dr. Luigi Gratton of the UCLA Center for Human Nutrition, gave a presentation to the Commission regarding youth health and nutrition. Dr. Heber highlighted preconception/pregnancy care as well as healthy nutrition and diet, physical activity, and weight management starting as early as birth. These factors can affect one's health later in life, including diabetes, body disorders, and other diseases.
July	Lisa Perry, Recreation Supervisor, and Laura Briceno, Recreation Coordinator, discussed the six preschools, summer camps, and youth programs in Beverly Hills. Health and safety practices in the preschool and/or camps include yoga and exercise classes, safe play guidelines, healthy snacks/lunch, visits from local doctors or dentists, teaching animal safety, safe tool handling practices, and earthquake drills.
September	Wil Master, American Red Cross Community Ambassador for Beverly Hills and National Disaster Responder, addressed the Commission regarding Red Cross youth programs, volunteer opportunities, blood donation, and fundraising events. Other youth programs include NexGenLA, AmeriCorps and Young Professionals.
October	Dr. Arash Asher addressed the Commission regarding Cedar-Sinai's GRACE (Growing Resiliency and Courage) program which helps individuals foster resiliency practices, including having a strong sense of meaning and purpose, mastering perspective, cultivating gratitude and humor, and connectivity.
November	Cheryl Karp Eskin addressed the Commission regarding Teen Line, a teen to teen hotline where teenagers can talk to a trained teen listener about anything they are struggling with.
December	Dr. Daniel Fink addressed the Commission on the topic of hearing and noise level health in youth.

The Beverly Hills Unified School District provided monthly updates on the following topics:

- 4. Raptor, a strict, security check program which screens all visitors prior to school entry.
- 5. Share911, a system to facilitate communications and information sharing on campuses that allows people to communicate important details during a crisis.
- 6. Safety initiatives such as cameras in the schools and lock down procedures.
- 7. Every 15 Minutes program, TUPE (Tobacco Use Prevention Education), and the California Smokers Helpline.
- 8. Successful sheltering in place practices.
- 9. Events to promote students walking to school.
- 10. Disaster training and security planning on school campuses.
- 11. Safety safety measures for graduation and summer school.
- 12. The Medical Science Academy, the Positive Behavior Intervention and Support program (PBIS), and HERO (Honorable, Engaged, Responsible, Open-Minded) programs.
- 13. Teaching online safety practices for students.
- 14. Suppressing vaping in schools.
- 15. The new financial literacy course that is now a graduation requirement in the Beverly Hills School District.
- The Beverly Hills Police Department provided monthly updates on the following topics:
- 16. The importance of neighborhood watch programs.
- 17. Coffee with the Cops events.
- 18. Free home inspections by the Police Department in an effort to prevent crime.
- 19. The Explorer Program, which gives teens the opportunity to assist the Police Department with non-hazardous tasks.
- 20. The importance of never leaving valuables in cars, in an effort to help prevent crime.
- 21. The importance of remaining vigilant and aware during the holiday season to help prevent theft.
- 22. The Town Hall meeting on May 1, 2019.

- 23. The Police Department Pancake Breakfast event on May 5, 2019.
- 24. The Beverly Hills Police Department's free mobile phone application.
- 25. Reminded the community to sign up for text and emergency alerts through the City's website and Nixle system.

Smoking Ordinance:

- 26. Passed the following motions that were combined in a draft ordinance recommendation to the Beverly Hills City Council:
 - Regarding the sale of all tobacco products in Beverly Hills, the Commission passed a motion to carve out the three cigar lounges in the City of Beverly Hills in existence as of March 25, 2019.
 - Regarding the sale of all tobacco products in Beverly Hills, the Commission passed a motion that there will be no carve outs for grocery stores, gas stations, convenience stores, and pharmacies.
 - Regarding the sale of all tobacco products in Beverly Hills, the Commission passed a
 motion to utilize a phase-in period of January 1, 2020 for pharmacies, January 1,
 2021 for gas stations and convenience stores (which includes liquor stores,
 convenience stores, and newsstands), and 1 year after the effective date that this
 ordinance is adopted for grocery stores and all other retail permit holders that are not
 specifically mentioned already).
 - Regarding the sale of all tobacco products in Beverly Hills, the Commission passed a
 motion that hotels will be permitted to sell tobacco products to their own hotel guests
 on a temporary basis (to be determined) that within these sales provisions, the sale
 can only occur through a concierge service, room service, or guest service option,
 and not through a retail establishment/store on the hotel premises open to the
 general public in a public area of the hotel.
 - Regarding the sale of all tobacco products in Beverly Hills, the Commission passed a motion that effective January 1, 2020, hotels will be limited to selling tobacco products to their hotel guests only with the provisions that the products may only be sold through a concierge service, room service, or guest service option, and that there will be no retail/shop or store front presence open to the public in the hotel selling the products. This will be in effect until January 1, 2022, where at that time hotels will no longer be permitted to sell tobacco products at all, including to their own hotel guests.
 - Regarding the sale of all tobacco products in Beverly Hills, the Commission passed a motion to enact an immediate moratorium on the submission, acceptance, and subsequent issuance of all tobacco retail permit applications.
- 27. Based on the draft ordinance recommendation, on June 4, the Beverly Hills City Council unanimously approved an ordinance to prohibit the sale of tobacco products in the City starting on January 1, 2021. The key provisions of the ordinance include:

- A permanent exemption/carve out for three existing cigar lounges;
- Effective January 1, 2021, hotels, existing and future, may only sell to guests;
- Effective January 1, 2021, all other businesses shall stop selling tobacco products;
- A hardship exemption provision for retailers that demonstrate the ban would cause undue hardship; and
- City Council review of the impacts on tourism in three years.
- 28. Provided information to businesses regarding programs and incentives that could help mitigate the impact to businesses from the tobacco sale ban.

Smoking Outreach:

- 29. Worked with staff to develop designs for new no-smoking signage and made recommendations for placement locations. Over 100 signs have been successfully installed.
- 30. Worked with staff to design smoking outreach collateral including poster boards, postcard mailers, a graphic redesign for the City's webpages related to smoking and vaping, pamphlets/flyers for youth anti-smoking/vaping, light pole banners, newspaper ads, pins, and social media posts.
- 31. Received information on the Small Business Development Center (SBDC) at El Camino College and the services it provides to local businesses, as well as the SCORE program, the nation's largest volunteer, expert business mentoring program.
- 32. Worked with Beverly Hills businesses to assist in employee smoking cessation efforts.
- 33. Provided input on survey development to determine smoking statistics as well as hiring Ambassador services.
- 34. Reviewed monthly Ambassador outreach data from October 2018 through November 2019, which totals to 8,162 contacts regarding smoking or vaping with an average of 580 contacts per month.

Smoking Enforcement:

- 35. Partnered with the Beverly Hills Ambassador team to help aid in smoking cessation efforts, including recording violations, referring repeated violations to Code Enforcement. Code Enforcement is able to send notices of violation, which can lead to criminal citations if additional violations occur. There are currently two full-time smoking specialist Ambassadors.
- 36. Received updates from Kris Zagyva, Operations Manager for Block By Block, about the responsibilities and effectiveness of the Ambassador Program on smoking in the Business Triangle and South Beverly Drive. Received information regarding how the Ambassadors work with Beverly Hills Code Enforcement and provided additional suggestions for enforcement effectiveness.

Smoking Cessation:

- 37. Partnered with Cedars-Sinai to offer a free-of-charge smoking cessation program to Beverly Hills residents and those who work within the City.
- 38. Received and expended grant funds from the Department of Justice to assist in smoking education, outreach, and cessation efforts.

Emergency Management:

- 39. Received information from staff regarding the ability to text 9-1-1 in the City of Beverly Hills.
- 40. Heard a presentation from staff on the seismic retrofit program.
- 41. Heard a presentation from the Beverly Hills Fire Department regarding brush clearances, compliance, and the upcoming fire season.
- 42. Informed the community of how to shut off gas in the event of an emergency and provided free shut off wrenches to meeting attendees.
- 43. Heard a presentation on safety measures taken by Southern California Edison to prevent and mitigate wildfires, including shutting off power to portions of the City.
- 44. Reviewed the Office of Emergency Management, Resilience, and Recovery's *Community Guide to Public Alert and Warning*, part of the City's overall Emergency Operations Plan (EOP), is a resource for the community to understand what tools the City possess in regards to both communication as well as alert and warning and how these tools may be used in emergencies and disasters.
- 45. Promoted the ShakeAlert phone application that provides earthquake warnings.
- 46. Reminded the community about the importance of being prepared and having a 15 minute evacuation plan.
- 47. Educated the community on the City's Alert and Warning Program and related resources.

Other Health and Safety Related Topics:

- 48. Heard a presentation from staff about the various duties performed by the Risk Management Division of Beverly Hills pertaining to health and safety, including the proper disposal methods for sharps and pharmaceuticals.
- 49. Reported that the City won an award from the States of California and Nevada National Association of Telecommunications Officers and Advisors for the Dangerstoppers: S.A.F.E. video, produced by the City's Cable Department.
- 50. Heard a presentation on the Beverly Hills Nurse Practitioner Program.
- 51. Reviewed the 2018 Water Quality Report.
- 52. Heard an update on the Metro construction project in Beverly Hills.

- 53. Began studying the topic of the potential health risks and considerations surrounding 5G networks.
- 54. Provided information regarding Invasive Aedes Mosquitoes from the Los Angeles County West Vector & Vector-Borne Disease Control District.
- 55. Presented various informational videos on a variety of health and safety related topics.
- 56. Reminded the community to not text and drive.
- 57. Reminded the community of the importance of vaccinations.
- 58. The Commission welcomed new Commissioner Kirk Y. Chang M.D., and incoming Commissioner Lee H. Hilborne, M.D.
- 59. The Commission honored outgoing Commissioners Myra Lurie and Gary Ross.

Beverly Hills Ambassador Program 2019 Annual Progress Report

The Smoking Outreach Ambassadors deployed into the Beverly Hills Business Triangle and South Beverly, focused on areas with the highest concentration of recorded smoking including Canon Drive, Beverly Drive, Rodeo Drive, South Beverly Drive and the adjacent alleys. Ambassadors educated violators of the Smoking Ordinance.

The grant funded Smoking Ambassador Program began in October 2018 and continued throughout the year of 2019. From October 2018 through December 2019, the Ambassadors engaged in 8,665 interactions to educate individuals observed violating the smoking ordinance and requested their compliance.

Ambassadors have continued to gather data regarding the locations of the most frequent violations of the smoking ordinance; and have continued to adjust the program deployment efforts as the data has been collected.

The City applied for additional grant funds from the State of California Department of Justice to continue the two smoking ambassadors past June 30, 2020, and the request was declined. Staff is currently requesting funding for two full-time Ambassadors through the City's annual FY 2020/21 budget process.

SUBJECT:	Discussion of Incoming Chair's Focus Area Topics, Areas of Interest, and Work Plan Initiatives

It has been the practice of the Commission that the Commission Chair names an Area of Focus for their term and that they provide suggestions and seek input on other Areas of Interest the Commission may want to cover or highlight in the coming year. This format was designed by the previous Commissioners to establish a map or guideline for the Commission to follow that provides a clear direction and focus and allows the Chair to highlight a specific topic. Also historically, in December the Commission identifies a work plan item to be included in the budget.

The Chair and Vice Chair for 2020 are Daniel Nazarian, DMD, and Cathy Baker.

The Commission approved the following area of focus, item of interest, and work plan item:

Area of Focus:

• Health and Safety Related Technology: Health and Safety Technology related topics, programs, presentations, outreach, and education.

Item of Interest :

• **Smoking:** Continue to support smoking outreach, education, enforcement, and cessation.

Work Plan Items for FY 2020-2021 (Budget)

- Develop and complete opportunities for the Commission on a variety of health and safety technology related topics, including 5G and community alert systems.
- Continue to support smoking related outreach, education, enforcement, and cessation.

The Commission will continue the tradition of honoring a community member, organization, or business that enhances the Health and Safety of the community. The Health and Safety awards will expand this year to now include a City employee that provides Health and Safety Excellence to the community. The Commission will have speakers on the topic of Health and Safety related technology, as well as receive updates from the Beverly Hills Unified School District, the Beverly Hills Police Department, and smoking updates from staff.
