

## BEVERLY HILLS POLICE DEPARTMENT EXECUTIVE SUMMARY November 2022

#### **Crime Summary**

In November 2022, we saw a **25%** decrease in overall offenses<sup>1</sup> compared to October 2022. Overall total offenses are marginally up by **10%** year-to-date. We have had two hundred and two offenses committed thus far in 2022 compared to 2021. Our response time to emergency calls for service is 2.40 minutes, and we received 3,185 community-generated calls for service.

#### **Community Engagement**

- ) Hosted a tour of the Police Department for 40 residents during Team Beverly Hills, with presentations led by Chief Stainbrook, the K-9 Unit, and the Force Options Simulator Instructor.
- ) Participated in a Meals on Wheels event along with former Beverly Hills Mayor Les Bronte and Chief Stainbrook, delivering meals to 30 families.
- ) Promoted public safety and awareness by hosting holiday preparedness meetings with businesses and hotels in the City and led security training for CBH employees in preparation for the holidays.
- ) The Explorer Program's Police Explorers won 1st Place in both Hostage Negotiations and the DUI scenario, placing 3rd Place overall against over 40 other teams at the Orange County Law Enforcement Explorer Advisor's Association's Competition. #### **Detective Bureau**

In May 2022, suspects forcibly entered a private residence in the 700 block of N. Camden Drive. The suspect's forced entry into the main bedroom pulled the male and female victims from the bed and proceeded to rob them. Detectives confirmed a suspect vehicle and two additional vehicles driving tandem to and from the location. Detectives conducted a thorough investigation and utilized all department resources and numerous warrants to ultimately file the case with the Los Angeles County District Attorney's Office Organized Crimes Division. The filing resulted in five felony warrants being issued for the suspects. On Wednesday, November 16, three suspects were located and arrested in conjunction with the crime.

In November 2022, a residential burglary occurred with a loss of \$54,000. With the assistance of the Real Time Watch Center (RTWC), Beverly Hills Detectives located a possible suspect leaving the immediate area shortly after the crime. Detectives ultimately identified the suspect through reports, prior police contacts, and video footage. The suspect was determined to be on active parole. Detectives successfully obtained a warrant for his arrest and facilitated with his parole officer to have the suspect detained and arrested for burglary.

#### **Traffic Division**

- Presented the Permit by Plate Transition Plan to the City Council Town Hall meeting. The following topics were discussed:
  - J The Enhancement of Public Safety
  - ) The Modernization of the 40-year-old plan
  - ) Communication to the community about the change
- Provided security for the Iranian march that took place in the business district with over 1,000 peaceful demonstrators.
- ) Coordinated multiple Golden Globes planning meetings and developed the final traffic and security plan.
- ) Hosted/instructed a DRE Recertification Course and worked with the Drug Influence Task Force and Park Rangers, resulting in two arrests and multiple positive contacts.
- Presented the Permit by Plate Transition Plan at the City Council Study Session with unanimous support by Council.
- Planned and implemented the Holiday Lighting Ceremony on Rodeo Drive and provided security for the annual Fur Free Friday march/ demonstration.
- Prepared the Staff Report to explore the Adoption of an Ordinance Establishing the Forfeiture of Nuisance Vehicles Engaged in Motor Vehicle Speed Contests or Exhibition of Speed.
- ) Increased its presence on Coldwater Canyon Drive to enforce speeding between 0630-0800 on Olympic Blvd and the southwest area of the City to enforce speeding and stop sign violations.



Crime Category	Sub-Category	Description
ASSAULT	Assault – Aggravated	An assault with a weapon or with the intent to inflict severe or aggravated bodily injury.
	Assault – Simple	An assault with no intent and not resulting in severe or aggravated bodily injury.
	Assaults – Prior to Sept 2018	All aggravated and simple assaults (previously combined).
BURGLARY	Burglary – Commercial Building	Entry into a commercial business after business hours with the intent to commit theft
	Burglary – Construction Site	Any entry onto a construction site with intent to commit theft.
	Burglary – Residential (Accessed Garage Only)	Entry <u>limited</u> to a garage (subterranean, attached to residence, detached from residence) with intent to commit theft.
	Burglary – Residential (Home Occupied)	Entry into a residence with the intent to commit a theft or any felony while the residence is occupied at the time of the crime.
	Burglary – Residential (Common Area)	Entry <u>limited</u> to a common mail area or laundry room of a multi-family residence with the intent to commit mail theft or coin theft.
	Burglary – Residential (No One Home)	Entry into a residence with the intent to commit a theft or any felony when no one is home at the time of the crime.
DUI ARREST		The arrest of a person for driving while under the influence of any alcoholic beverage or drug.
HOMICIDE		The willful (non-negligent) killing of one human being by another.
MOTOR VEHICLE THEFT	Motor Vehicle Theft	The theft of a motor vehicle.
ROBBERY	Shoplift Robbery	A shoplifter uses force against store security to retain property stolen from the location.

	Burglary – From a Motor Vehicle	Forced entry into a locked motor vehicle with the intent to commit theft.
