

BEVERLY HILLS POLICE DEPARTMENT EXECUTIVE SUMMARY May 2022

Crime Summary

In May 2022, we saw a **24%** increase in overall crime¹ compared to April 2022. Overall total crime is marginally up by **1%** year-to-date. We have had four more crimes committed thus far in 2022. Our response time to emergency calls for service is **2.52** minutes, and we received **3,988** community-generated calls for service.

Community Engagement

- The Beverly Hills Rotary Club presented the Community Relations Unit (CRU) with the Vocational Service Award and was featured in the Beverly Hills Courier.
- The Social Media Team continued to increase followers and promote. The department's Instagram profile reached 385% more accounts and increased engagement by 55.4% compared to April. There was an increase of almost 700 followers. The most successful Instagram Reel reached over 258,000 accounts, received over 4,300 likes and over 270 comments, and was shared on Instagram almost 2,500 times.
- CRU visited nine different religious institutions to provide guidance and reassurance due to the recent shooting at a church in Orange County.
- CRU participated in the following outreach activities: the Annual Women for Israel Luncheon, Cinco de Mayo BHPD Meet & Greet with Next Beverly Hills, Fire Service Day at BHFD, Police Service Day & BHPOA Community Breakfast, and met with executive-level representatives from over 20 businesses at the Rodeo Drive Committee's monthly meeting.
- CRU conducted 14 one-on-one BHPDalert training sessions with sworn supervisors.
- Conducted bi-weekly foot beats to promote safety and security and met with business owners and employees from over 20 businesses in the 9400 block of Brighton Way and the 200 block of S. Robertson Blvd.

Detective Bureau

- On May 3rd, Beverly Hills Police officers responded to the 700 block of North Camden Drive for an armed robbery investigation. Multiple armed suspects entered the location and forced the residents to surrender their property. There were no injuries reported in this case. A follow-up investigation led to the identification and subsequent arrest of two suspects.
- On May 18th, two suspects were arrested for their involvement in multiple commercial burglaries. From early March through mid-May, the suspects engaged in multiple burglaries of medical offices in Beverly Hills and throughout L.A. County.

Traffic Division

- The Traffic Division increased enforcement in the business district during the evening hours related to ongoing loud exhaust & speed complaints.
- Traffic personnel assisted the Beverly Hills Farmers Market Bike Safety Booth for Bike Month.
- The Traffic Division hosted and instructed advanced roadside impaired driver (ARIDE) training for all department personnel and outside agencies.
- In addition, the Traffic Division assisted Community Services with developing and implementing a public safety plan for the Beverly Hills Art Show.





Crime Category	Sub-Category	Description
ASSAULT	Assault – Aggravated	An assault with a weapon or with the intent to inflict severe or aggravated bodily injury.
	Assault – Simple	An assault with no intent and not resulting in severe or aggravated bodily injury.
	Assaults – Prior to Sept 2018	All aggravated and simple assaults (previously combined).
BURGLARY	Burglary – Commercial Building	Entry into a commercial business after business hours with the intent to commit theft
	Burglary – Construction Site	Any entry onto a construction site with intent to commit theft.
	Burglary – Residential (Accessed Garage Only)	Entry <u>limited</u> to a garage (subterranean, attached to residence, detached from residence) with intent to commit theft.
	Burglary – Residential (Home Occupied)	Entry into a residence with the intent to commit a theft or any felony while the residence is occupied at the time of the crime.
	Burglary – Residential (Common Area)	Entry <u>limited</u> to a common mail area or laundry room of a multi-family residence with the intent to commit mail theft or coin theft.
	Burglary – Residential (No One Home)	Entry into a residence with the intent to commit a theft or any felony when no one is home at the time of the crime.
DUI ARREST		The arrest of a person for driving while under the influence of any alcoholic beverage or drug.
HOMICIDE		The willful (non-negligent) killing of one human being by another.
MOTOR VEHICLE THEFT	Motor Vehicle Theft	The theft of a motor vehicle.
ROBBERY	Shoplift Robbery	A shoplifter uses force against store security to retain property stolen from the location.
	Robbery	The taking of anything of value from a person by force or threat of force or violence.
SEX CRIMES		Includes rape, sexual battery and sex registrant violations.
THEFT/LARCENY	Theft – Grand	Theft where the value of the property exceeds \$950, or is taken from a person, or a firearm of any value.
	Theft – Petty	Theft where the value of the property is less than \$950.
	Theft From Commercial Building	Theft (regardless of value) from a commercial business, building or office.
	Theft of Auto Parts	Theft, limited to auto parts, from the interior or exterior of a vehicle.
VANDALISM		The malicious destruction, damage or defacing (graffiti) of real or personal property of another.
VEHICLE BREAK- IN/THEFT	Theft – Grand (From Vehicle)	Entry into a motor vehicle, without force, where the property stolen exceeds \$950.
	Theft – Petty (From Vehicle)	Entry into a motor vehicle, without force, where the property stolen is less than \$950.
	Burglary – From a Motor Vehicle	Forced entry into a locked motor vehicle with the intent to commit theft.
