## **INTRODUCTION**

This meeting will be a joint meeting of the City Council Liaison /Rodeo Drive/ Special Events/ Holiday Program Committee; and the City Council Liaison /Chamber of Commerce Committee; as well as the City Council Liaison /CVB/ Marketing Committee (Liaisons). For the purposes of today's discussion, the Liaisons and business partner organizations will discuss opportunities to collaborate to tell the story of Beverly Hills and continue to encourage residents and visitors to come to Beverly Hills.

## DISCUSSION

The City of Beverly Hills provides annual funding to the local business partner organizations known as the Rodeo Drive Committee (RDC), the Beverly Hills Chamber of Commerce (Chamber), and the Beverly Hills Conference and Visitors Bureau (CVB). Each partner organization executes a work plan and/or marketing programs to promote Beverly Hills. Target audiences vary by agency however they include visitors to Beverly Hills, businesses in Beverly Hills, as well as those businesses considering moving to Beverly Hills, and residents of Beverly Hills. Marketing efforts are curated to reach specific target audiences including, but not limited to, the drive market Greater Los Angeles region visitor all the way to the international tourist visitor and applicable residential/visitor domestic markets in between. Additionally, the City of Beverly Hills offers various events and programs across multiple City departments to encourage both visitors to Beverly Hills and residents of Beverly Hills to shop, dine, play and stay in Beverly Hills.

## FISCAL IMPACT

There is no direct fiscal impact related to the discussion topic at today's meeting. Any requests for new projects, events, initiatives, or funding will be brought back to the Liaisons and the full City Council for approval as needed.
