

Beverly Hills Police DepartmentExecutive Summary - July 2023

Crime Summary

In July 2023, we saw a **1% increase** in offenses¹ compared to June 2023. Overall total offenses are up by **15% year-to-date**. We have had two hundred and thirty-seven crimes thus far in 2023 compared to 2022. Our response time to emergency calls for service is 2.29 minutes, and we received 3,959 community-generated calls for service.

Community Engagement

- Our Community Relations Unit (CRU) coordinated the Junior Police Academy (JPA) from July 14-18, hosting 16 children. In collaboration with Community Services, the JPA is a summer camp program designed for children aged 10-12 years old, available to both City residents and non-residents. The camp offers a diverse range of activities, including a police station tour, K-9 Unit demonstrations, SWAT presentations, Traffic awareness, Defensive Tactics sessions, and insights into Crime Lab procedures. - Sgt. Newman, in conjunction with the Traffic Bureau, organized a comprehensive two-day Standardized Field Sobriety Testing (SFST) training seminar. Additionally, Sgt. Newman conducted another session of the Oral Interview Preparatory Course, designed to assist aspiring police officers in their journey. - CRU paid a visit to the General Pediatrics and Pediatric ICU at Cedars-Sinai Medical Center, offering patients a unique perspective on police operations and government service. The next visit to Cedars-Sinai is scheduled for late August.
- Conducted security assessments and convened meetings to coordinate the preparation for BHPD's largest event of the year, National Night Out.
- Filmed a <u>Virtual Ride-Along</u> exclusively on BHPD's Instagram stories featuring Sgt. Newman, who answered prepared questions from the public while conducting traffic stops in the City. The 20-part series received between 2,200 and 3,300 views for each story and positive feedback online and from the community.
- Addressed a critical issue through social media by producing a <u>Public Service Announcement</u> (PSA) regarding the danger of leaving children and animals unattended in vehicles, particularly during the hot summer months. Highlighting a real-life incident in January 2021, a vigilant bystander alerted BHPD, leading to the timely rescue of a young child from a hot vehicle. Statistics from the National Highway Traffic Safety Administration reveal that approximately 40 children perish from heatstroke each year due to being left or trapped in cars. The PSA emphasized that in just 25 minutes, the temperature inside a car can surge to 100°F, even when the outside temperature is a mere 73°F. On the day of the incident, the vehicle's interior temperature was measured at 75°F. This social media post had an impressive response, amassing over 33,500 views with nearly 1,600 likes, and reached over 29,000 accounts.

Investigative Services Division

- In May of 2022, a home-invasion robbery occurred in Beverly Hills. After a thorough investigation, several suspects were arrested, and warrants were issued for the outstanding suspects. On July 18th, 2023, Detectives responded to the Las Vegas Metropolitan Police Department jail where the last outstanding suspect of the robbery had been arrested. The suspect was extradited to the Los Angeles County jail where he remained in custody.
- Over the span of several days, three separate thefts occurred in which the suspects used sleight-of-hand techniques to steal high-end jewelry from victims. Detectives were quickly able to identify a suspect vehicle and a search/arrest warrant was executed resulting in numerous pieces of evidence being recovered and one suspect being arrested.
- During the month of July, two victims were robbed at gunpoint for their watches. With the assistance of LASD West Hollywood, the department's virtual patrol officers, and drone operators, the suspect vehicle was identified. Just a few hours after the robbery, the suspect vehicle was spotted back in the City of Beverly Hills. Patrol units stopped the vehicle and detained the occupants. Officers discovered two firearms and the originally stolen property from the victims. Ultimately, four suspects were arrested.
- Officers responded to a stolen vehicle alert and detained the driver. During the stop, it was determined the vehicle was not stolen and the plates from a stolen vehicle had been placed on the driver's vehicle. During the investigation, the driver was found to be in possession of a smart card reader, multiple blank access cards, and unauthorized identification documents. Through investigative follow-up, detectives determined the driver was in possession of fraudulent vehicle registration documents. The case was presented to the Los Angeles County District Attorney's Office who charged the driver with PC 484i(c) Making, possessing, or trafficking in incomplete access cards or card-making equipment and CVC 4463(a)(1) Using a false registration card, license, license plate, permit, or evidence of vehicle ownership.
- On July 11th, detectives took a suspect into custody in connection with the theft of five luxury vehicles which occurred in the City of Beverly Hills between September 2022 and June 2023. Following the arrest, a search warrant was served at the residence of the suspect and additional evidence linking him to the auto thefts was recovered. The Los Angeles District Attorney's Office filed several felony and misdemeanor charges including multiple counts of grand theft auto, receiving stolen property, and identity theft.

Traffic Bureau

- In July 2023, Traffic Control Officers (TCOs) issued 6,249 parking citations, 315 signed citations, and 1,840 Photo Red Light citations.
- A media release was sent out reminding the public to drink responsibly at their Fourth of July celebrations.
- On July 14th, the Office of Traffic Safety funded primary crash factor enforcement day and DUI saturation patrol.
- On July 20th and July 21st, the Traffic Bureau coordinated and instructed a Standardized Field Sobriety Testing course. This course was attended by two Beverly Hills Police Department officers and officers from seven outside agencies.







