## About the Preschool

The City of Beverly Hills Community Services Department proudly offers a year-round preschool program at 6 classroom sites for residents of Beverly Hills with children 3 to 5 years of age.

Children must be three years old and toilet-trained before starting school.

Although these programs are recreational in nature, fundamental building blocks and tools necessary for a child to successfully integrate into Kindergarten are provided. These programs prepare children for Kindergarten through the development of socialization and interaction skills.

Children will learn the basics such as ABC's, color, shapes, numbers and begin their appreciation of the arts and science. A healthy snack is provided at all schools daily. Parents must provide lunch each day their child attends.

All children are encouraged to realize their full potential, while at the same time, helping them to recognize socially acceptable norms within the preschool environment as a stepping stone to Kindergarten.

Our preschool programs are licensed by the State of California and comply with all licensing guidelines and requirement. All programs embrace the highest standards of conduct, health and safety.



## Program Philosophy

Early childhood should be a time of joy, comfort, excitement, exploring and discovery. Preschool age children are both open and receptive. Our program nurtures and encourages these qualities in its students through a combination of structured group time and individual creative learning in a positive environment. We utilize a development approach and provide experiences which promote curiosity and develop cognitive, language, social and fine and gross motor skills. The children are encourage to actively explore their environment and acquire skills through a combination of play, small and large group activities, and direct instruction.

## The Teaching Staff

The staff instructs in a nurturing and cooperative team-teaching format. All sites have an on-site director (Head Teacher), a Teacher and a Teacher's Assistant. All teachers have a background in Early Childhood Education and meet all the teacher qualifications for State licensing requirements.



## Hours of Operation/Cost

All six school sites are offered Monday-Friday with options of attending 5 days per week, 3 days per week (M/W/F), or 2 days per week (T,TH), depending upon availability. Registration costs for preschool range from approximately \$4,000 to \$10,000 a year, depending upon number of days selected.

### HOW TO REGISTER

The popularity of these preschools has necessitated the establishment of a waiting list and Beverly Hills residents will receive first priority. Non-residents will be placed on a waitlist for the preschool locations on PARK sites only.

**(P.O. Boxes or business addresses do not qualify as a resident.)**

The following information is REQUIRED to be placed on the waiting list:

- A photocopy of your current water bill or Southern California Edison bill.
- A photocopy of your child's birth certificate.
- A non-refundable \$25 waiting list fee.
- Child must be 2 year old to be placed on the waiting list.
