RULES FOR AUTO/MOTORCYCLE ENTRY

All automobiles and motorcycles must be pre-registered. Release of liability, payment of fees and color photograph or high res jpg via email **MUST** accompany each application to allow for consideration.

1. The Committee reserves the right to create, combine or divide classes.
2. The Committee reserves the right to accept or deny any entry. Applicants will be notified of acceptance or denial on or about April 1, 2017. If accepted, an exhibitor packet will be included with show details and tickets.
3. Automobile and motorcycle placement will occur (at exhibitor's option) Saturday, May 6 (10am – 12pm ONLY) or Sunday, May 7 (7am to 8:30am). NO automobile or motorcycle will be permitted to enter the venue after 8:30am on May 7.
4. Preference for acceptance will be given to vehicles that were NOT shown in the 2016 event and to vehicles manufactured prior to 1974.
5. All automobiles and motorcycles must remain in position at the concours until the awards have been presented and permission is given to remove vehicles, without exception.
6. No signs (including "for sale"), displays, stanchions or illustrations are allowed.
7. Pets are NOT allowed at Greystone Mansion/Estate per City of Beverly Hills regulations.
8. Pop-up tents/canopies are NOT permitted. Appropriate lawn or other chairs are permitted.
9. Best of Class Awards are self-judged by the participants of the given class. Sponsor awards are selected by the sponsor, with all other awards selected by the Concours Committee using the "French" system of judging.

INFORMATION AND INSTRUCTIONS

Parking for exhibitors' trailers, trucks, etc., will be located on Doheny Road, adjacent to Greystone Estate, which provides easy access. (Maps will be provided).

Photographs of vehicles to be exhibited will be printed in the Greystone Mansion Concours program if photograph is received by March 1, 2017.

If accepted, exhibitors may purchase up to (4) additional tickets at the reduced price of \$100 each. Confirmation of acceptance will be sent upon approval of Exhibition Committee.
