California ID and a utility bill are required, at time of payment, as proof of eligibility for the resident rate; postal boxes are not accepted. Either partner must be a resident of Beverly Hills to qualify for the resident rate. This permit entitles the holder to use of the Beverly Canon Gardens grounds only. All checks must be payable to "City of Beverly Hills".
