DESCRIPTION

- 7a. Architectural style: Georgian Revival
- 7b. Briefly describe the present *physical description* of the site or structure and describe any major alterations from its original condition:

An unusually literal interpretation of Georgian Revival precedents, this is a twoand-one-half story brick house. Its steeply pitched hipped roof is accented by hipped dormers and a tall, corbelled brick chimney, and crowned by a balustrade. A double course of raised bricks divide the first and second floors. They are interrupted by the entry, which is centered in the perfectly symmetrical facade. Framed by pilasters and a denticulated, arched pediment, the entry contains a panelled door surmounted by a transom. Soldier arches chracterize the two six-over-six sash on either side of the entry. Raised lintels detail the identically placed windows on the second story. Other notable features include a denticulated cornice, a partially wood-sheathed bay on the north, and another chimney in the rear. Formal landscaping enhances the design, which appears unaltered.



SIGNIFICANCE

19. Briefly state historical and/or architectural importance (include dates, events, and persons associated with the site.)

An early example of Georgian Revival architecture with brick veneer, this 1921 home on upper Beverly Drive was the home of William Rokham. It was designed and built by local architect and contractor J. A. Melton. Rokham, a wealthy collector of antiques, had this house designed in a very traditional style, possibly to facilitate a background for his collection. As a rare example of this type of American Colonial Revival architecture in Beverly Hills, the residence is worthy of note in the context of the City's variety of architectural styles.


