2. Kusama Update

Staff reported that they have continued working with the City Attorney's Office in resolving the ongoing issues with the Kusama sculpture. Staff has reached out to Ota Studios multiple times since January 2017 but the studio has not responded.

Susan Gersh, former Fine Art Commissioner and current Recreation and Parks Commissioner, addressed the Commission to inform them that due to her contacts with the Zwirner Gallery a representative of the Gallery had offered to reach out to Mr. Ota on her upcoming trip to Japan on behalf of the City. The Commission accepted this generous offer and are very appreciative of the offer to reach out by the Zwirner Gallery and they thanked Commissioner Gersh for her help. The Commission had asked Staff to seek outside counsel on this situation.

3. Art Signage

Staff presented renderings of the proposed art signage, its wording and positioning of the signage around the sculptures. Staff will provide a sample of the proposed art sign for the April meeting.

4. City Website Updates

Following up on the Commission's suggestion, staff has added to the Fine Art webpage a link to the Charitable Foundation that will allow donations for the Public Art Program. The Commission asked staff to review the wording for the pieces donated to the City and ensure acknowledgement on City website.
