


Electric Vehicle (EV) Charging Policy

On July 5, 2016 the City Council of the City of Beverly Hills approved to implement a uniform rate structure in all City parking facilities after it was unanimously approved by the Traffic and Parking Commission.

The use of the Electric Vehicle (EV) has grown with the demand of the EVs on the market. As a result, the City parking facilities needed to make changes to the EV Policy to accommodate the growing EV user population.

Why a New EV Policy?

The EV Charging Policy encourages better utilization of the City's current EV charging infrastructure to allow for the growth.



How Many EV Stations Are Available?

The City of Beverly Hills currently operates 35 publicly available electric vehicle (EV) charging stations, providing:

• 59 Level 2 connections

Charging Stations are in 14 public City Public Parking facilities and at Roxbury Park.

Charging Station FeesAdditional to facility parking fees

Energy Fee

\$.25 per KWh

& Station Fee

FREE first two hours

\$6.00 Each additional hour

City Fees

Energy Fee: a fee associated with the amount of energy consumed by the connected vehicle.

Increment 1 - \$0.25 per kWh

Station fee: A fee associated with the length of time a connection is established with the station, irrespective of whether the vehicle is charging

Increment 1 - First two hours free

Increment 2 - \$6.00 per hour thereafter

Enforcement and Citation

- Non Battery-Only (BOEVs)
- Any vehicle without an actively charging session
- Any vehicle not connected to a station may be subject to citation or tow at owner's expense.

B.H.P.D. enforces EV Charging Policy inherent in the City Parking EV signage and may result in the removal of a vehicle from a stall or space designated for an electric vehicle.

Reserved for Battery-Only Electric Vehicles (BOEVs)

ALL OTHER VEHICLES WILL BE TOWED

Subject to citation and or tow at owner's expense:

- Non-BOEVs
- Any vehicle not connected to station
- Any vehicle without active charging station session
