1. 9908 SOUTH SANTA MONICA BOULEVARD Mixed Use Overlay Zone (PL1509126)

Request for a General Plan Amendment, Zone Text Amendment, Planned Development, Vesting Tentative Tract Map and Development Agreement to create a Mixes Use Planned Development Overlay Zone (M-PD-5) and allow a five-story, mixed-use project consisting of 27 residential condominium units and 13,036 SF of ground floor retail in a Commercial Zone on the property located at 9908 South Santa Monica Boulevard. Pursuant to the provisions set forth in the California Environmental Quality Act (CEQA), the Planning Commission will also consider a Final Environmental Impact Report. Continued from the January 11, 2018 Planning Commission Hearing.
