- Chair Pynoos noted that Mayor Mirisch had requested an educational program or information that can be shared with the school district.
- Chair Pynoos also mentioned upcoming preservation conferences Docomomo's annual conference in Phoenix in March, and Palm Springs Modernism Week in February, at which Stephen Price will be speaking about Trousdale Estates.

COMMUNICATIONS FROM STAFF

Urban Designer Updates

- City Planner Ryan Gohlich provided an update on the City Council's recent action on the appeal of the Planning Commission's decision regarding the properties at 332-336 North Oakhurst Drive; the project was denied (approving the appeal). The property owner has three options: to restore the buildings with the possibility of a conversion to condominiums, to submit a new application for a redesigned project that will be reviewed by the Planning Commission, or to develop a project that is entirely within the City of Los Angeles.
- Urban Designer Mark Odell advised that the Mills Act Pilot Program had been extended by the City Council. The next steps are to establish a permanent program, to which the City Council seems receptive.
