- Commissioner Waldow noted an Ad Hoc Committee meeting that had been held with Commissioner Beck and staff, to discuss the establishment of standards for the relocation of historic properties
- Commissioner Greer posed the idea of a column, written by staff, that encourages and educates readers on historic preservation, which could be published in a local newspaper
- Commissioner Beck noted that the 45-year criteria used in the assessment of potentially historic properties is a suggestion, rather than a rule
- Commissioner Greer mentioned the possibility of a bus tour of historic properties, as suggested in the past by Councilmember Mirisch
- Commissioner Waldow suggested incorporating historic properties in the Walk with the Mayor program

Urban Designer Updates

- Urban Designer Mark Odell provided updates on the following:
 - The California Preservation Foundation's annual conference will be held in May this year; Commissioners are welcome to attend, along with a number of staff members.
 - The City Council recently designated the Samuel Goldwyn Estate as a Local Landmark
 - The City Council also approved a Mills Act Contract for the Landmark Property at 328 South Rexford Drive.
 - The Golden Shield program continues to progress; the expected next steps are a meeting with City Council Liaisons, and a final review by the full Cultural Heritage Commission before the item appears on the City Council agenda.
 - New City Council Liaisons are Councilmembers Mirisch and Wunderlich.
- City Planner Ryan Gohlich reviewed the new priority-setting process that will be utilized by the City Council on its upcoming meeting on Thursday, April 20, 2017.
