 Director of Public Works, Shana Epstein, provided updated information regarding water rate notices.

3. La Cienega Park and Recreation Complex Public Engagement Project Project Update Presentation and next steps.

Community Services Department Director, Nancy Hunt-Coffey, provided an update on the La Cienega Park and Recreation Complex Public Engagement Project that has been underway since last summer.

Staff attended the November 20, 2018 City Council Meeting and presented their initial report on the Public Engagement Process. Consultant David Ceppos reported on the findings of that process and the City Council was asked to give initial direction on features to be considered at La Cienega based on that feedback.

The City Council was interested in maintaining the current uses of La Cienega Park in addition to the consensus of exploring a public swimming pool; the possibility of either basketball courts or a gymanisum; updating the Community Center; providing additional shading and green space, improving the playground and restrooms, expanding the duplicate bridge club facilities; improved parking and exploring some water feature.

There was also interest in a pedestrian land bridge over La Cienega Boulevard that would take people from the parking structure to the east side where the fields are. There was support for a small library like the one at Roxbury Community Center.

The final report from this extensive outreach effort will be presented to City Council at the December formal meeting. Commissioners are encouraged to attend the Council meeting and hear the final report presentation and the Council discussion, public comment, and possible direction or action.
