## REPORTS FROM PRIORITY AGENCIES

Assistant Director Gil Borboa reported on issues the Metropolitan Water District is currently working on including a pilot program to fund direct use stormwater capture programs. The Commission was provided with the most recent News Release and Board Report/Action on this topic.

## 5. 100 Block El Camino Ficus Street Tree Master Plan

Urban Forest Manager Ken Pfalzgraf provided an update on tree replacement in the 100 block of El Camino Drive, including the process outlined in the Street Tree Master Plan to remove and replace trees. The ballot was sent out and responses were received.

# 2. Capital Projects Update

Engineering Manager Robert Welch highlighted projects from the report including the Oil Well Plugging and the Metro Section 2 Project, specifically the Caňon Drive cul de sac. There was a reminder about the September 19 public scoping meeting for the North Portal.

#### Comments from Commissioners:

- The Commission commended staff for arranging the tours of the oil well site and briefly discussed the location of the air quality monitors.
- The Commission inquired about a worker who was injured during the recent flare incident at the oil well and praised the response from the emergency workers. There were some additional follow up questions related to fire safety systems and placement of air quality monitors that will be answered at a future Commission Meeting.
- Comments were also made about the Sunset Reservoir Project and the budget of the La Cienega/Frank Fenton Field Stormwater Project. There was also a request for an update/summary of the video inspections for the stormwater and drain rehabilitation, and the water main leak on La Cienega was discussed.
- The Commission commented and made suggestions about the formatting of the Capital Projects Update report.
- The Commission requested clarification on the Coldwater Water Main Project.
- The Commission requested updates for the Fiber to the Premise Project.

The Commission took a break at 9:42 AM.

The Commission returned at 9:53 AM.

3. Foothill Water Treatment Plant Update/La Brea Subarea Update

Assistant Director Gil Borboa presented a PowerPoint presentation prepared for an upcoming City Council Meeting. Additionally the schematic layout for the Water Treatment Plant was reviewed. Water Resources Manager Vince Damasse gave a progress update of the Water Treatment Plant and the La Brea Subarea.

The Water Efficiency Ad Hoc, comprised of Commissioners Felsenthal and Alpert, reported in detail on their recent meeting.

## Commissioner comments:

- The Commission discussed some differences regarding dates indicated on the slides vs. their memory of when certain events occurred.
- The Commission disagreed with the graphic representation showing we get 80% of our water from Met (including the conservation number in the overall water portfolio) when it is in actuality 100%.
- The Commission inquired about the filtration systems being proposed for use in the water treatment plant.
- The layout/design for the Water Treatment Plant was discussed at length with a recommendation from the Ad Hoc Committee that additional consideration be given to expanding the plant into the observation room so as to allow for better future space management in the event additional filtration or other forms of water treatment are required.
