## • Urban Designer Updates

- Staff provided updates on the following:
  - Properties at 1035 Summit Drive, 1100 Carolyn Way, and 1119 San Ysidro Drive are currently under review for possible Historic Incentive Permits.
  - Staff has submitted to the California Preservation Foundation, an application for a Preservation Design Award for the City's renovation and rehabilitation of Beverly Gardens Park.
  - The Ahmanson Bank & Trust Building at 9145 Wilshire Boulevard, which is Local Landmark No. 26, is now owned and will be occupied by Chabad of Beverly Hills. A restoration plan is expected to be received by the City within the next year.
  - The Gibraltar Square Kate Mantilini Building at 9101-9111 Wilshire Boulevard, which is Local Landmark No. 30, currently has an application under review that is requesting conversion of the tower into a hotel with associated hotel amenities, and to reoccupy the Kate Mantilini space as a restaurant associated with the hotel.
