# 1. Health and Safety Recognition Program

# 2. Smoking Update

Michael George, Management Analyst, provided status updates to the Commission on the City's various smoking programs including the no-smoking signage project. The signage designs have been finalized and are being prepared for fabrication. The specific locations for the signage are still being decided, and staff is working with the consultant on additional collateral that can be given to businesses for employees. A grant modification request has been submitted to the Department of Justice that, if approved, will allow for a second dedicated smoking ambassador to begin work in the upcoming fiscal year. This request is currently pending approval by the Department of Justice. The free-of-charge City-sponsored Smoking Cessation Program offered through Cedars Sinai has served 10 participants and the City is preparing to continue the Program in the next fiscal year. Kris Zagyva, Block by Block's Operations Manager, informed the Commission that the Ambassadors are recording smoking violations in the City and once an individual is contacted three times, the Ambassadors refer the case to Code Enforcement. Nestor Otazu, Code Enforcement Manager, reported that Code Enforcement has been sending notices of violation, which can lead to a criminal citation if additional violations occur. An informational Beverly Hills This Week video was shown regarding the City Council recommendations to prohibit the sales of tobacco products in the City. The informational video Dangers of e-cigarettes, vaping, and JUULS: How to talk to kids presented by The MD Anderson Cancer Center from The University of Texas was not shown.

One community member made a public comment regarding smoking in the City.

# 3. Youth Health and Safety

Jennifer Lev, Recreation Services Manager, informed the Commission about safety procedures for youth in the Beverly Hills Basketball League, the Beverly Hills Little League, and the American Youth Soccer Organization. This includes health and safety officers,

# 4. Seismic Retrofit Program

There will be a Soft-Story Seismic Retrofit Fair on May 30, 2019 at the Civic Center Court Yard. An informational *Beverly Hills This Week* video on Earthquake Awareness Month was shown.
