## 1. Smoking Update

Michael George, Management Analyst, provided updates on the smoking/vaping violations observed by the Ambassador Team during the month of June, Department of Justice grants for anti-smoking/vaping initiatives, the deployment of the second full time Smoking Ambassador, the status of the no-smoking signage fabrication and installation including sign locations, the status of the public information and social media campaigns, enamel pin designs, and the free-of-charge City-sponsored Smoking Cessation program hosted by Cedars-Sinai. ### 2. Youth Health and Safety

Lisa Perry, Recreation Supervisor, and Laura Briceno, Recreation Coordinator, discussed the six preschools, summer camps, and youth programs in Beverly Hills. Health and safety practices in the preschool and/or camps include yoga and exercise classes, safe play guidelines, healthy snacks/lunch, visits from local doctors or dentists, teaching animal safety, safe tool handling practices, and earthquake drills.

#### **NEW BUSINESS**

#### 3. Nurse Practitioner Program

Sean Stokes, EMS Administrator, Scott Marquez, Firefighter Paramedic, and Nurse Practitioner Teri Simmons addressed the Commission regarding the Nurse Practitioner Program. The program is a unique and innovative Emergency Medical Service (EMS) model, designed to deliver advanced, efficient and effective healthcare in the pre-hospital setting. BHFD's vehicle, 'Nurse Practitioner 1' (NP1), will respond to calls for service in the field. Staffed with both a Nurse Practitioner and Firefighter Paramedic with oversight from a board certified Emergency Medicine physician, NP1 is equipped with an array of medications, select laboratory diagnostics and technical medical equipment. Whether responding to 911 calls or following up on 'in home' patient referrals, NP1 will provide mobile urgent care as well as collaborate with primary care providers in order to optimize greater long term health and wellness within our community.

# 4. Water Quality Report

Gilbert Borboa, Assistant Director of Public Works, and Jason Dyogi, Water Quality Specialist, addressed the Commission regarding the 2018 Water Quality Report. The report includes the source of drinking water, risks to water sources, regulated contaminants found, health effects, educational statements, and contact information. The Commission reminds everyone to have water purification tablets in the event of an emergency.
