REPORTS FROM PRIORITY AGENCIES

- Beverly Hills School District Rachelle Marcus, Board Member, updated the Commission on the Medical Science Academy, the Positive Behavior Intervention and Support program (PBIS), and the school athletic programs. The Commission welcomed Scott Lovelace, the new Director of Safety, for the Beverly Hills School District.
- Beverly Hills Police Department There was no report this month.

CONTINUED BUSINESS

1. Health and Safety Recognition Program

Commissioner Demeter honored former Health and Safety Commissioner Gail Millan for her significant contributions to the health and safety of the community.

2. Employee Emergency Management Excellence Award

The City's Office of Emergency Management created the Employee Emergency Management Award to recognize employees who have gone beyond their daily responsibilities to contribute to the City's emergency management efforts. During this meeting, this award will be given to Michelle Fieler, Detective Specialist.

3. Smoking Update

Michael George, Management Analyst, provided updates to the Commission on no smokingvaping initiatives. The report covered the Ambassador outreach data, including an update on the second full time Ambassador, Code Enforcement data, and public information activities including postcard mailers being sent to residents/businesses, outreach booths and rollup banners at City events, newspaper ads and social media posts, lapel pins, outreach cards, vouth pamphlets/flyers being shared with all schools in the City, and the free-of-charge Citysponsored Smoking Cessation program offered through Cedars-Sinai. The Commission also received updates on a potential smoking-vaping cessation program between the City and The Maple Counseling Center, a forthcoming street pole banner campaign, posters for businesses, and additional no smoking-vaping signage that will be installed in locations across the City. Currently, 15 signs have already been installed. The City is awaiting the grant application results from the State of California Department of Justice regarding potential funding to cover future outreach, education, cessation, and enforcement efforts for smoking and vaping. 5. Southern California Edison Wildfire Mitigation, Safety, & Grid Resiliency

Diane Forte, the Government Relations Manager for Southern California Edison (SCE), addressed the Commission regarding safety measures taken by SCE to prevent and mitigate wildfires, including shutting off power to portions of the City. 6. Metro Construction Update

Robert Welch, Engineering Manager, provided the Commission a construction update on the Metro Purple Line. It is expected to be operational prior to 2028. There will be some traffic and construction impacts in the surrounding areas prior to the operational functioning of the stations. Metro is introducing the Business Interruption Fund and Eat Shop Play, two programs to assist businesses.
