REPORTS FROM PRIORITY AGENCIES

 Beverly Hills School District - Rachelle Marcus, Board Member, reminded the Commission that April is Autism Awareness Month. Chris Hertz, Director of School Safety, commended the school staff, security officers, and Beverly Hills Police Department for a successfully executed school shelter in place on March 15, 2019.

CONTINUED BUSINESS

1. Health and Safety Recognition Program

Commissioner Myra Demeter honored Rabbi Michy Rav-Noy, Executive Director, and Miriam Rav-Noy, Program Director, from Friendship Circle Los Angeles. The Friendship Circle's mission is (1) to provide Jewish children who have special needs with a full range of social, recreational, educational and Judaic experiences; (2) to provide their parents with respite and support; and (3) to enrich, inspire and motivate Jewish teenagers through sharing of themselves with others. An informational video was shown.

2. Smoking Update

Michael George, Management Analyst, and Kris Zagyva, Block by Block Operations Manager, (1) informed the Commission on the progress of the Ambassador education, outreach, and enforcement program for the City's no-smoking policies; (2) gave an update on the forthcoming no-smoking signage in the City; and (3) provided details on the possibility of applying for additional grant funding from the State of California Department of Justice to further support the City's no-smoking programs. Staff to bring back grant expenditures/reimbursements per the request of Commissioner Demeter.

NEW BUSINESS

3. Study of Banning the Sale of All Tobacco Products in Beverly Hills

Logan Phillippo, Policy & Management Analyst, spoke to the Commission regarding the possibility of an ordinance to ban the sale of all tobacco products in the City. The updated timeline and dates for discussion at Health and Safety Commission meetings and City Council meetings were reiterated. Staff clarified what constitutes a tobacco product as well as potential recommendations to clarify aspects of the definition. A proposed ordinance will include a hardship exemption that permit holders can apply for under certain conditions. Penalties and enforcement measures for violations of the Municipal Code as it relates to tobacco sales were discussed

38 individuals or organizations made a public comment with the request that cigar lounges be exempt from any possible ban. 9 individuals or organizations made a public comment in support of the ban. 7 individuals or organizations made a public comment in opposition to the ban. 2 individuals or organizations made a public comment neither in support nor against the ban. 9 individuals or organizations filled out comment cards, but left the meeting prior to being called for public comment.
