NEW BUSINESS

1. Presentation from Small Business Development Center Regarding Business Impact Mitigation Related to a Potential Tobacco Sales Ban

Laura Biery, Marketing and Economic Sustainability Manager, Blair Schlecter, Vice President of Economic Development and Government Affairs for the Beverly Hills Chamber of Commerce, and Lawrence Johnson, Director for the Center for Strategic Corporate Development from the Small Business Development Center (SBDC) at El Camino College, spoke to the Commission about the comprehensive services provided by SBDC to local businesses. This includes consulting, financing/loans assistance, marketing and social media efforts, educational workshops and events, and a variety of additional services. The City already pays for membership through its partnership with the Chamber of Commerce. Businesses that could be affected by a potential tobacco ban could utilize these extensive resources free of charge. Also highlighted was the SCORE program, the nation's largest volunteer, expert business mentoring program.

Two community members made public comments on the effect of the possible tobacco sale ban on businesses.

2. Tobacco Sales Ban Policy Discussion Regarding Hotel Businesses

Logan Phillippo, Policy & Management Analyst, reminded that on April 22, 2019, the Commission voted on a motion to annul the hotel carve out vote taken at the March 25, 2019 Health and Safety Commission meeting and to schedule a Special Meeting on April 29, 2019 at 3:00 p.m. to re-vote on the hotel carve out.

 Motion for a permanent carve out for hotels to sell tobacco products to their hotel guests only.

Motion: MOVED by Commissioner Lurie, NOT SECONDED

Motion that hotels will be permitted to sell tobacco products to their own hotel guests on a
temporary basis (to be determined) that within these sales provisions, the sale can only
occur through a concierge service, room service, or guest service option, and not through
a retail establishment/store on the hotel premises open to the general public in a public
area of the hotel.

Motion: MOVED by Commissioner Baker, SECONDED by Commissioner Demeter

to approve the motion (4-0).

• Motion that effective January 1, 2020, hotels will be limited to selling tobacco products to their hotel guests only with the provisions that the products may only be sold through a concierge service, room service, or guest service option, and that there will be no retail/shop or store front presence open to the public in the hotel selling the products. This will be in effect until January 1, 2022, where at that time hotels will no longer be permitted to sell tobacco products at all, including to their own hotel guests.
