PROJECT UPDATES, STATUS REPORTS, STAFF REPORTS

- 6. Director's Report
 - a. Information only items
 - Alexandra Nechita artwork was approved at August 20, 2019 City Council Meeting. Staff will meet with Public Works Department to discuss timeline of installation.
 - Kusama loan agreement is moving forward. Artwork is scheduled to be picked up in March 2020.
 - Kusama refabrication has begun. Art Bronze has created a 3-D rendering and is in communication with Otta Fine Art Studios. The first visit for first set of approvals will likely take place in January 2020.
 - Bove artwork will remain covered for protection while the City works with fabricator to discuss repairing clear coat peeling issue. Staff met with artist attorneys to discuss moving art piece, but they are reluctant.
 - Plaques for art pieces are still in progress to ensure uniformity.
 - Ai Weiwei agreement is almost finalized. The City rejected licensing and copyright language in new draft and Ai Weiwei has agreed to all of it except for two items. The City has updated language and the latest draft is currently under review by Ai Weiwei's attorney. A timeline for installation and panel discussion about the piece will be shared with the Commission when it becomes available after docketing the final agreement.

- Mayor's Community Pops Concert and Singalong with the LA Lawyers Philharmonic on October 1, 2019 was a success.
- Ringo Starr artwork base is currently being installed. The concrete needs to cure and the piece will be installed after the art show. Estimated installation is early November. Once staff has an installation event date, it will be shared with the Commission.
- Beverly Hills Art Show coming up on October 19th and 20th from 10:00am to 5:00pm.
- Paul Paolone, Senior Recreation Supervisor, presented the monthly Fine Art fund reports and provided information on pending permits and fees.
- Maple Drive and Beverly Hills Hotel missing art status is still in process with the Community Development Department. City Attorney's Office still figuring out how to do a code enforcement action.
- Staff reported that three art pieces can be added to Public Art Archive. The next step is to have the terms of use signed off by Westaff, company that manages Public Art Archive. They will be flexible with the City regarding agreement.
- Jean Highstein artwork still pending approval by donor due to installation costs. Risk Management will decide if art piece could be free-standing in the event that the donor rejects installation costs for a concrete base.
- **b.** Staff added a calendar of mayoral initiatives for the Arts and Culture Commission to attend.
