NEW BUSINESS

1. Novel Coronavirus Overview

Fire Chief Gregory Barton addressed the Commission regarding COVID-19.

Jennifer Garland, RN, PhD, CIC, with Cedars-Sinai's Department of Hospital Epidemiology, updated the Commission on COVID-19. Her presentation is summarized here: To help prevent infection, it is important to protect one's eyes, nose, and mouth by not touching one's face, and to maintain a social distance from other individuals. It is important to wash your hands and use hand sanitizer. At this time, evidence suggests that it is droplet and contact transmitted as opposed to airborne. Symptoms can include fever, cough, difficulty breathing, and myalgia or fatigue. It is important for healthcare professionals to identify, isolate, and inform when it comes to potential patients. It is important for people with COVID-19 to wear masks to protect others from getting infected. Please visit https://www.cdc.gov/, for more information.

Meena Janmohamed, Emergency Management Manager, updated the Commission on COVID-19.
