4. Beverly Hills Homeless Initiative

James R. Latta, Human Services Administrator, updated the Commission on the details of the Beverly Hills Homeless Initiatives that the Commission recommended. Staff continues to work on the Commission's request:

- Advocate for expanded outreach services On Wednesday March 31, 2021, Community Services, along with Police and Fire Department representatives, met with Program Managers from the Department of Mental Health's Emergency Outreach and Triage Division. They presented their Mental Health Evaluation Team partnerships with various police departments and municipalities throughout Los Angeles County. The presentation was well received and next steps would include an onsite visit to discuss what a partnership would look like with Beverly Hills
- Continue to support our community partners
- Advocate for a Department of Mental Health
- Recommend that the City Council take an innovative approach to homeless services
- Education: The pandemic has exacerbated the homelessness issue throughout Los Angeles County, California and the entire Nation. In Beverly Hills, residents have noticed an increase in visible homelessness in public areas. Last month, staff suggested the Commission take a proactive approach to educate the community on the homelessness crisis, the City's response, and encourage residents to be a part of the solution. The staff recommendation of hosting virtual community forums with the below topics required additional discussion:
 - Meet Beverly Hills Homeless Outreach Team, Rangers, & Ambassadors
 - Homeless Legislation with speakers from Sheila Kuehl and/or Richard Bloom's offices
 - Meet our Homeless Service Providers- PATH, Step Up on Second, local faith based groups
 - Challenges of Housing Chronically Homeless Individuals
