## **REPORTS FROM PRIORITY AGENCIES**

### **Beverly Hills Police Department**

Acting Captain Max Subin, updated the Commission on the following:

- 7 Explorers are currently in the Police Explorer Academy.
- Bicycle officers are deployed from 6am – 4pm to address the homeless individuals in addition to any calls. They work with Human Services if anyone is requesting service.
- The department has received numerous calls regarding panhandling in addition to car racing. Two motor officers have been deployed on Friday and Saturday nights.

Beverly Hills Board of Education member, Dr. Amanda Stern, provided an update on the following:

- August 13, 2021 was the first day of school. Screenings continue when students and staff arrive. The state has mandated that all school employees are vaccinated or are tested. The District follows the Los Angeles Department of Public Health guidance.
- The high school students can change their grade to pass or fail if they're not happy with the letter they receive.
- The athletics have started up
- The middle school is having a back to school carnival August 20, 2021.
- Chair Blumenfeld reminded Dr. Stern that October is Civility Month and the Commission looks forward to engaging the students to participate.

### **2. Beverly Hills Homeless Initiative**

Enisha Clark, Interim Clinical Program Coordinator, provided an update on the status of the Beverly Hills Homeless Initiative:

- With the additional Community Assistant Grant Funding (CAGF) that the Commission recommended for Step Up on Second, an additional outreach worker was hired to provide coverage on Saturdays, Sundays in addition to early morning and late evening coverage. Outreach services are now available seven days a week.

### **4. Inter-Commission Collaboration: Embrace & Celebrate Culture Initiative**

Jenny Rogers, Director of Community Services, provided a background on this initiative for the new Commissioners in addition to updating the Commission on the current active collaborations:

- Sing for Hope Pianos: 16 pianos were decorated and disbursed around the City. After September 6, 2021, they will be gifted to local schools and communities throughout Los Angeles
- The Visions of the Future is a collaboration with the Next Beverly Hills Committee. The kick-off art reception was held on July 14, 2021 where a dedication ceremony celebrated a new art pop-up featuring artist James Goldcrown at 455 N. Canon Drive. The exhibit will be available through the end of August 2021.
- Currently, both the Arts and Cultural and Human Relations Commission are working on new exhibits which will be announced soon.
- Chair Blumenfeld requested Commissioner Freeman remain as the liaison and requested Commissioner Margo replace Commissioner Saleh.

## NEW BUSINESS

### 5. Embrace Civility Award

Rachel Evans, Interim Human Services Administrator, updated the Commission on the presentation of the Embrace Civility Award in October 2021.

- Chair Blumenfeld announced the nomination period at the July 2021 Mayor's Cabinet Meeting. The deadline to submit a nomination is Friday, September 3, 2021.
- The promotion and marketing plan was reviewed and though nominations have been submitted, the Commission is encourage to continue to promote the award.


