5. Frieze Los Angeles 2022 – Ad Hoc Committee's Proposed Initiatives

The Commission's Ad Hoc Committees proposed various initiatives for City participation in Frieze Los Angeles 2022. Commissioners presented their ideas then voted on their top two choices out of five. The following initiatives were suggested and include the voting results:

- Fine Art/Public Art & Cultural Events Ad Hocs
 - Docent Art Walk Tours (30%)
 - Commissioning Site-Specific Dance Performance (0%)
- Music and Community Outreach Ad Hoc
 - Welcome Reception with Gallery Open House (40%)
 - Creative Community Arts Event (20%)
- Art Maintenance Ad Hoc
 - Citywide Exhibition (10%)

The Commission's top choice is a welcome reception with gallery open house, followed by docent art walk tours. The Fine Art / Public Art and Cultural Events Ad Hocs will take the lead on continued development of the docent art walk tours; the Music and Outreach Ad Hoc will be the lead committee to coordinate the welcome reception; and the Art Maintenance Ad Hoc will continue to support maintenance and enhanced cleanup of artworks in Beverly Gardens Park leading up to the fair in February 2022, with all Commissioners participating in welcoming Frieze LA 2022 to the City of Beverly Hills.

CONTINUED BUSINESS

6. Financial Update

Paul Paolone, Acting Interim Arts and Culture Manager, reported on the Fine Art Fund and informed on pending permits and fees. An additional \$30,500 was transferred as of October 2021 for a total of \$64,385 in In-Lieu Fee Revenue in FY 21/22.

PROJECT UPDATES

• Sing for Hope Beverly Hills Update

All pianos have been delivered to school locations. Staff is waiting for to hear from school schedules for ribbon cutting ceremonies. Information will be shared with the Commission once available.

- Beyond 2021 Exhibition with UTA Update The exhibition was originally proposed as part of Embrace and Celebrate Culture Initiative in December 2020, but due to the rise of COVID-19 cases, was postponed. The program was postponed again in summer 2021 and will now take place from Thanksgiving in November through the month of December 2021 in partnership with UTA. The exhibit is slated activate the storefront windows of the former Barney's department store building.
- Fine Art Collection Maintenance Program Update Cleaning of artworks is scheduled in preparation of the Beverly Hills Fall Art Show taking place on October 16-17, 2021. On October 18-19, 2021, Rosa Lowinger & Associates (RLA) will be cleaning and wrapping artwork located on the Burton Way Median due to the Burton Way Median Project. Staff has followed up with art donors to keep them informed of the process. Rosa and her staff recommended fencing artworks for protection during the project. When work on the project nears a particular artwork, it will be wrapped to best protect the artwork and reduce prolonged coverage time, which could damage artworks.
