3. Frieze Presentation from City Council Meeting on January 4, 2022

proposed resolution implements the necessary requirements.

Frieze Director Christine Messineo presented the Frieze Sculpture Beverly Hills 2022 program to the Commission which included details on sculptures to be installed along Beverly Gardens Park in February 2022 as part of *Frieze Week in Beverly Hills*. Eight of the galleries are regional and include Beverly Hills gallery, Gagosian. The installation period is planned for February 1-8, 2022 and de-installed during the first week of May 2022. Frieze is working with the City on organizing a reception that is tentatively slated for February 10, 2022. The Commission shared some concern about Covid-related protocols, but Christine reassured Commissioners and the public that Frieze London and Frieze New York were successful events during the pandemic and Frieze Beverly Hills is following all required safety procedures.

# PROJECT UPDATES

- Frieze Week in Beverly Hills Update
  - a) Commissioner Vahn commented on the docent program. The Frieze docent program will station one docent at each sculpture to provide a high quality experience for those touring. The docent program will then continue post-Frieze Week with the City's permanent Fine Art Collection and artworks installed as part of the Frieze Sculpture Garden Beverly Hills through the end of April, 2022.
  - b) The Beverly Hills Historical Society volunteered to offer materials to include in storefront window displays during *Frieze Week in Beverly Hills*. Commissioner

Beck and Chair Frank along with staff will meet and plan the activation of empty storefronts with the Beverly Hills Historical Society.

• Fine Art Collection Maintenance Program Update Recreation Supervisor Adriné Ovasapyan provided an update on in-progress and future art maintenance. The sculptures on the Burton Way Median will not require cleaning prior to re-wrapping with continued work on the Burton Way Median Project. Staff is scheduling cleaning of artworks prior to Frieze Week. Sculptures at Beverly Gardens Park, City Hall Campus, Library, Rodeo Drive, Electric Fountain and the Brainwash pieces will be cleaned. This cost will be reflected in the upcoming month's Fine Art Fund update.
