REPORTS FROM PRIORITY AGENCIES

Beverly Hills Police Department

Lieutenant Giovanni Trejo updated the Commission on the following:

- The Real Time Watch Center, a new hub to coordinate the City's many surveillance tools, officially launched June 7, 2022.
- On Tuesday, June 7, 2022, the department hosted Breakfast with the Badges at Mickey Fine Pharmacy on Roxbury Drive in Beverly Hills. These events are creating networks of communication with the Community.
- June 20 24, 2022, the department will be hosting the Junior Police Academy.
- June 28, 2022, 9am 10:30am, Coffee with the Cops will be held at Starbucks at 9811 S. Santa Monica Boulevard.
- August 2, 2022, National Night Out from 6pm 9pm.

Beverly Hills Unified School District

Beverly Hills Board of Education member, Dr. Amanda Stern, provided an update on the following:

- The high school graduation and promotion ceremonies have concluded.
- For the summer, there will be a middle school boot camp at Beverly Hills Education Foundation (BHEF).
- At the last school board meeting, Juneteenth was presented with African American speakers discussing their experiences of being students in the district during the 1970s.

NEW BUSINESS

3. Civility Month

In 2017, the Commission declared October as Civility Month in Beverly Hills to further the civility initiative in the City. To commemorate the month, banners and posters will be displayed throughout the City.

- The Commission reviewed the current branding and agreed to continue with what is familiar to the City but suggested possible patches on the banner for updating.
- Commissioner Laura Margo presented more details of a Citywide donation day that would take place during Civility Month. It was agreed the Ad Hoc would meet to finalize to present to the Commission's liaisons.

4. Embrace Civility Award

The Embrace Civility Award, established in 2012, recognizes individuals or groups in the community that exemplify any or all of the following:

- Acts as a role model of positive behavior
- Takes a stand in support of respect and responsible actions
- Promotes positive neighbor to neighbor relations

The Embrace Civility Award nomination period will be announced and launches at the July 11, 2022 Mayor's Cabinet Meeting. Commissioners are asked to encourage community participation in the award program and motivate people to complete a nomination application. The nomination period closes on Monday, August 22, 2022.

5. Mental Health Awareness

At the May 19, 2022 Commission Meeting, Vice Chair Freeman requested that a Mental Health Awareness item be agenized.

Rachel Evans, Human Services Administrator, informed the Commission on status of the City's Mental Health Evaluation Team (MET).

- DMH clinician is partnering with a police officer to join in mental health calls
- The DMH clinician can write mental health holds
- The request went to City Council on May 24, 2022 where it was unanimously approved
- Los Angeles County, in addition to our Police Department, will be hiring staff

Vice Chair Freeman informed the Commission that she did ask Mayor Bosse if there was a conflict with her mental health speakers.

- Vice Chair Freeman was informed the Commission could suggest speakers in addition to teaming up with the Health & Safety Commission or start their own initiative of taking care of one's mental health.
- Commissioner Kaiserman suggested partnering up with National Alliance on Mental Illness (NAMI).
- Staff will contact NAMI to schedule a speaker for a future Commission meeting.

Jenny Rogers, Director of Community Services, informed the Commission that July is National Park and Recreation Month that staff is considering partnering with Parks Prescription. ParkRx is a program encouraging people to spend time in nature.

- Vice Chair Freeman informed all of the nationwide hotline going live on July 16, 2022. The hotline is intended to be like 911, but for psychiatric instead of medical emergencies. That number will be 988.

CONTINUED BUSINESS

- 6. Beverly Hills Unified School District Engagement Project The Ad Hoc was unable to meet and still waiting for proposals.
- 7. FY 2022-23 Community Assistance Grant Fund (CAGF)

Rachel Evans, Human Services Administrator, informed the Commission that on June 14, 2022 City Council unanimously approved all of the Ad Hoc's and Liaisons' recommendations. Staff thanked Chair Sharp, Commissioner Nisim and Vice Chair Freeman for their hard work during this process.

- Commissioner Nisim thanked staff for their hard work in addition to making the process organized for them.

8. Beverly Hills Homeless Initiative

Enisha Clark, Human Services Specialist, introduced the members of the Beverly Hills Homeless Outreach Teams who provided the Commission with their responsibilities in addition to success stories:

- Beverly Hills Outreach Team (BHOT) consisting of Kevin Conner, Sabreah Sanchez and Ed Chavous who provide homeless outreach and linkage support to Step Up's services.
- Chris Paulson, Recreation Services Manager, introduced the two Park Ranger Supervisors, Daniel Hernandez and Juan Andrade. They updated the Commission on the Ranger program and how they coordinate with the Outreach Team. The Rangers launched a bike team in September 2021. In addition, the Park Rangers started an Outreach Program in 2021 which patrols all the parks at 5am, Monday – Friday.
- Vice Chair Freeman suggested a video of the above-mentioned staff and resources to show how unique the City of Beverly Hills is with the provided services. Staff agreed and will follow-up.
- Enisha Clark, Human Services Specialist, reminded the Commission that the best initial number is to contact the BHOT Team at 310-487-0313.
- Diversity, Equity & Inclusion Awareness Initiative Enisha Clark, Human Services Specialist, updated the Commission on the Ad Hoc's June 8, 2022 meeting to finalize the first event.
 - The first in-person event will be Donzaleigh Abernathy, author and civil rights activist. Her father is Reverend Ralph Abernathy who was an influential leader in the Civil Rights Movement. This event is scheduled for August 24, 2022 at 7pm.
 - The Beverly Hills Public Library is co-hosting this event which will be held in the Library's Auditorium.

Jenny Rogers, Community Services Director, informed the Commission that the City will be acknowledging Juneteenth with the scheduled Concerts on Canon being held this evening, June 16, 2022 at Beverly Canon Gardens.

10. Inter-Commission Collaboration: Embrace & Celebrate Culture Staff viewed the video created by Beverly Hills Cable Television from the City's Pride Night.

11. Kindness Recognition

Linda Kyriazi, Recording Secretary, thanked Commissioner Margo for agreeing to replace a last minute cancellation by a Recreation and Parks Commissioner who was to be a judge at Sunday's Farmers' Market Piesta event.

Johnthon Hunter, Beverly Hills Ambassadors Operations Manager, reviewed the latest camping activity in the City structures with the Commission:

- Camping activity has increased by May going up 15% but still less than last year.
