#### **PROJECT UPDATES**

- Program Updates
  - January 10, 2022, the City reverted back to a remote status with the schedule for preschool and classes reviewed, rescheduled or provided as a virtual event.
  - The reopening of preschools is scheduled for February 1, 2022 with a new Covid testing process in place for both staff and students.
  - The Beverly Hills Public Library has reduced their hours for the month of January and a "grab and go" sidewalk check-out is in place. The library will begin reopening in a phased approach.
  - The Beverly Hills Farmers' Market suspended the prepared food, entertainment, sitdown area in addition to the small petting zoo.
